Honorable Chairman and Trustees:

I. SCOPE

Amendment No. 2 is the final amendment to reconcile all the quantities installed in the field. Change Order No. 2 adds a new pay item and a time extension to the contract.

II. JUSTIFICATION

Amendment No. 2 reconciles all quantities installed on the contract. Change Order No. 2 adds black concrete pavement and 7 days to the contract time due to additional concrete replacement required to complete cut and plugs on the old water main, and also to allow time for the punch list verification walkthrough.

IV. COST SUMMARY

Amendment No. 1	\$57,984.50 (3.65% Increase)
Change Order No. 1	\$45,506.25 (2.87% Increase)
Amendment No. 2	\$44,718.25 (2.82% Increase)
Change Order No. 2	\$5,269.20 (0.33% Increase)
Revised Contract Amount	\$1,740,669.20

Amendment No. 2 is an increase of \$44,718.25 or 2.82% above the original contract amount. Amendments Nos. 1 and 2 represent an increase of \$102,702.75 or 6.47% above the original contract amount. Change order No. 2 is an increase of 5,269.20 or 0.33% above the original contract amount. Change orders Nos. 1 and 2 represent an increase of \$50,775.45 or 3.20% increase over the original contract amount. Amendment No. 2 and change order No. 2 result in an overall increase of \$49,987.45. The revised total contract amount is \$1,740,669.20.

V. **CONTRACT TIME**

The original contract called for 180 calendar days with the work order start date of March 11, 2024. Change Order No. 1 added 26 days to the contract. Change Order No. 2 adds 7 days to the contract. The total contract duration is now 213 calendar days. The contract end date is October 10, 2024.

The above and foregoing is hereby accepted this 25th day of October, 2024; and the undersigned agrees to perform the work at the price indicated.


