

**RESOLUTION AUTHORIZING THE PURCHASE OF
AMBULANCES, EMS, AND OTHER SPECIAL SERVICE VEHICLES
THROUGH A COOPERATIVE AGREEMENT WITH HOUSTON-
GALVESTON AREA COUNCIL (CP24-C245010), ESTIMATED COST
\$1,000,000, SEPTEMBER 26, 2023 THROUGH SEPTEMBER 25, 2024.**

WHEREAS, the Fire Department has a continuing need to purchase fire apparatus replacement vehicles which are available through Houston-Galveston Area Council (H-GAC); and

WHEREAS, the H-GAC cooperative purchasing program, known as HGACBuy, benefits government agencies by providing national pricing through competitively solicited proposals; and

WHEREAS, HGACBuy is a government-to-government cooperative purchasing program that has been in operation for over 30 years; and

WHEREAS, the cooperative provides volume purchasing pricing and discounts to local governments, special districts, and non-profits providing a government service; and

WHEREAS, this contract adoption will allow the Fire Department to purchase ambulances, fire apparatus, and other specialty service vehicles, such as a landing craft boat, at a discounted price under H-GAC's contracts, Ambulances, EMS, and Other Special Service Vehicles, #AM10-20; and

WHEREAS, price lists are attached to each contract; and

WHEREAS, staff will consider delivery timeline and price when utilizing the cooperative agreements; and

WHEREAS, the City is under no obligation to purchase from this agreement; and

WHEREAS, all purchases are subject to future appropriations and the availability of funds; and

WHEREAS, there is a continuing need for the procurement of these vehicles.

NOW, THEREFORE, BE IT RESOLVED by the Council of The City of Oklahoma City that they do hereby authorize the purchase of ambulances, fire apparatus, and other specialty

service vehicles through a cooperative agreement with Houston-Galveston Area Council (CP24-C245010), estimated cost \$1,000,000, September 26, 2023 through September 25, 2024.
