Ratifying and approving Addendum No. 1; awarding contract to Globe Construction Co., Project BC-0219 Phase IV, Pedestrian Bridge Decorative Fencing, Northwest Expressway and West Wilshire Boulevard, \$435,323; and approving contract and bonds. Ward 1.

Location:

Northwest Expressway and West Wilshire Boulevard

Background:

This 2017 General Obligation Bond Authorization listed project provides design and construction of the pedestrian bridge and trail connection. Once Phase I construction began, the need to secure the area under the ramps and bridge outside of the street was identified. Phase IV provides decorative fencing that will enhance esthetics and secure the areas beneath the bridge.

The project was advertised, and bids were received from prospective bidders. Addendum No. 1 was required to answer pre-bid questions and correct plan sheets.

Construction is scheduled to begin Spring 2024 and be completed in Summer 2024.
