MEMORANDUM OF AMENDED RETAIL WASTEWATER SERVICE AGREEMENT

This Memorandum of Amended Retail Wastewater Service Agreement ("Memorandum") is entered into on this 30th day of January, 2024, by and among the City of Oklahoma City ("Oklahoma City"), the Oklahoma City Water Utilities Trust ("OCWUT"), (collectively, "OKC/OCWUT"), and Independent School District No. 6 of Oklahoma County, Oklahoma, a/k/a Deer Creek Public Schools ("Owner") as the sole owner of the School Site as more particularly set forth on **Attachment "A"** hereto ("School Site").

1. The Parties have entered into an Amended Retail Wastewater Service Agreement ("Amendment") approved by Oklahoma City on the 20th day of January, 2024, for the purpose of authorizing Oklahoma City and OCWUT to provide wastewater services in Oklahoma County, outside of the Oklahoma City limits, to the School Site. All of the foregoing is set forth in the Amendment.
2. The initial Retail Wastewater Service Agreement was ratified and approved by the Amendment. Retail wastewater service was made available to the Deer Creek Schools 4th and 5th Grade Center and will be made available to the Deer Creek Schools 4th and 5th Grade Center, the Deer Creek Schools Middle School, and the related Deer Creek Schools Middle School facilities on the School Site for the term and as provided in the Amendment until terminated as provided in the Amendment.
3. The Agreement affects the real properties described in **Attachment "A"** ("School Site"), which is attached hereto and incorporated herein.
4. Owner may receive wastewater services on the School Site subject to the terms of the Amendment. Owner, and its successors and assigns, agree to and are subject to the conditions, restrictions, and requirements in the Amendment and the Oklahoma City Municipal Code, and any amendments and additions thereto, as contract terms, though outside the Oklahoma City limits. In the event of a conflict between the Amendment and the Oklahoma City Municipal Code, the Oklahoma City Municipal Code will control; however, any provision or portion of the Amendment not directly in conflict with the Oklahoma City Municipal Code will apply and be enforced.
5. The wastewater rates and charges to the Owner will be different from the wastewater rates and charges to other properties but shall be equal to similarly situated classes of users, if any.


