

CONTRACT

THIS CONTRACT AND AGREEMENT, made and entered into this 29TH day of JANUARY 2024, by and between the MCGEE CREEK AUTHORITY, party of the first part, hereinafter termed “Trust” and Wynn Construction Co., Inc., party of the second part, hereinafter termed “Contractor”.

WITNESSETH:

WHEREAS, the MCGEE CREEK AUTHORITY has caused to be prepared in accordance with law certain specifications, and other bidding documents for the work hereinafter described and has approved and adopted all of said Bidding Documents, and has caused Notice to Bidders to be given and advertised as required by law, and has received sealed proposals for the furnishing of all labor and materials for: Project No. WMC-040 Revised, McGee Creek Pipeline Cathodic Protection Improvements, McGee Creek Reservoir as outlined and set out in the Bidding Documents and in accordance with the terms and provisions of said contract: and,

WHEREAS, Contractor, in response to said Notice to Bidders, published in The Journal Record, October 4th and 11th, 2023, submitted to Trust in the manner and at the time specified, a sealed proposal in accordance with the terms of this Contract; and,

WHEREAS, the Trust in the manner provided by law, has publicly opened, examined, and canvassed the bids submitted and has determined and declared the above named Contractor to be the lowest responsible bidder on the above described Project, and has duly awarded this Contract to said Contractor for the sum named in the bids, to wit: Eight Hundred Forty-One Thousand Four Hundred Sixty and No/100 Dollars (\$841,460.00).

NOW, THEREFORE, for and in consideration of the mutual agreements and covenants herein contained, the parties to this contract have agreed and hereby agree as follows:

1. The Contractor shall, in a good and first-class, workmanlike manner, at his own cost and expense, furnish all labor, materials, tools, and equipment required to perform and complete said work in strict accordance with this Contract and the plans and specifications adopted and approved by MCGEE CREEK AUTHORITY, all of which documents are on file in the Office of the City Clerk of The City of Oklahoma City and Secretary of the McGee Creek Authority and are made

a part of this Contract as fully as if the same were herein set out at length, with the following additions and/or exceptions: (if none, so state) None.

2. The Trust shall make payments to the Contractor in the following manner: On or about the first day of each month, the City Engineer, or other appropriate person, will make accurate estimates of the value, based on Contract prices of work done and materials incorporated in the work and of materials suitably stored at the site thereof during the preceding calendar month. The Contractor shall furnish to the City Engineer, or other appropriate person, such detailed information as he may request to aid him as a guide in the preparation of the monthly estimates.

Each monthly estimate for payment must contain or have attached an affidavit as required by 74 O.S. § 85.22.

3. On completion of the work, but prior to the acceptance thereof by the Trust, it shall be the duty of the City Engineer, or other appropriate person, to determine that said work has been completely and fully performed in accordance with said Contract Documents, and upon making such determination, said official shall make his final certificate to the Trust. The Contractor shall furnish proof that all claims and obligations incurred by Contractor in connection with the performance of said work have been fully paid and settled; said information shall be in the form of an affidavit, which shall bear the approval of the surety on the Contract bonds for payment of the final estimate to the Contractor; thereupon, the final estimate (including retainages) will be approved and paid and the same shall be in full for all claims of every kind and description said Contractor may have by reason of having entered in to or arising out of this Contract.

4. The sworn and notarized statement below must be signed and notarized before this contract will become effective.






