**XII. Comments from Council**

Councilperson Cooper congratulated all college graduates, specifically the stars at Oklahoma City University, and thanked the students for engaging conversations in his World Literature course. He's looking forward to a staycation this summer and a break from teaching, but not from research and writing, as he prepares for the fall. He invited everyone to The Paseo ribbon cutting at 11:00 am this Friday at NW 30th and Paseo.

Councilperson Hinkle thanked the local Firefighters Union 157 for the invitation last weekend to the Smoke and Guns Charity Event in Tulsa. Isaac Sader, Seth Maxwell and Ryan Finlason, Oklahoma City Police Officers, represented the City well in the MMA boxing match style event. The charities are great, and the event was very well done. Councilperson Hinkle also thanked Councilperson Stone for the beverage.

Councilperson Nice congratulated the latest Cohort of the Progress OKC Business Accelerator Program for founders of different businesses. This past week there were 18 presenters with wonderful businesses needing funding. She believes eight Cohorts have graduated. She mentioned there will also be presentations this week from the Oklahoma City Minority Founder Accelerator Program. She gave a shout out to On Point Dance Studio, a local dance studio within our community, as they had their dance recital themed "The Wiz."

She also congratulated the Class of 2024 Cohort's in the Master's Degree Program for Regional and City Planning as quite a few of them are obtaining their degrees this semester. She also mentioned, Langston University had their graduation this past Saturday and was thankful the weather was better than the previous schedule date.

Councilperson Nice congratulated Representative Jason Lowe as a member of the Divine 9. We are excited to have him as a part of the organization.

Councilperson Nice thanked the City of Muskogee as one of their Council Members invited her to be a moderator of one-on-one conversation with Dr. Bernice King, the daughter of Dr. Martin Luther King, Jr. She was excited to be a part of the conversation and to meet a King legacy. She was grateful to meet the Mayor and a couple of the Council members at the beautiful Martin Luther King Junior Community Center where the conversation was held.

Councilperson Nice thanked Devon Energy for their investment in USA softball and women's sports with their generous donation and the naming rights. It is now officially called Devon Park and it's official because you can see it outside of the building. We are extremely excited to again support what women's sports has been able to produce for not just Oklahoma but a global stage for women's sports as well. She understands the impact of what these places mean and how we talk about bringing in and promoting tourism for our communities. This will be a great gift and they've already branded it very well. We look forward to the Big 12 Championship that's going to be played within this next week and Boomer Sooner.

Councilperson Stonecipher stated his favorite budget meeting is when Russell Evans, Economist, presents to the City Council. He takes complex materials in a presentation that's understandable and helpful. Russell has a new report out and it's called the *2024 Greater Oklahoma City Economic Outlook*. There are three important things in the report: 1) Job growth in 2024 is estimated to add nearly 14,000 new jobs primarily in the health services trade sector. 2) Income and salaries are on the rise in Oklahoma City. 3) We have a high concentration of young people in the metro area that should provide a labor pool support system for years to come. Councilperson Stoncipher stated when he was growing up in the 80s and 90s a lot of his friends moved to other cities to find work, so this is a significant moment in the history of Oklahoma City when we have a large labor youth population that will provide workers for our workforce. He encourages you to read it you can get it on the Oklahoma City Chambers website. Mr. Evans states the caveat to the report is the local economy remains volume vulnerable due to national and global uncertainties that may disrupt economic conditions, but on the whole the city is doing great.

Vice-Mayor Peck recognized our Youth Council completed their 23-24 experience with our offices and departments within the City and we're just grateful for their interest and participating in getting involved with civic leaders. She hopes they will go off to college and come back to Oklahoma City and be the next leaders in the next generation. We had a great group of young adults; the interviews are going on right now for the next class of leaders and so we're excited for next year.

Vice-Mayor Peck had an opportunity to visit the Mike Monroney FAA Aeronautical Center City Manager and had a great meeting with staff there and a nice tour of the facility. It was a great experience and it's very interesting to learn all of the different government agencies that now hold up shop there and to participate in collaborative efforts that benefit the greater good and Oklahoma City. They teach various classes, bring in people nationwide to educate our air traffic controllers and many other positions, including technicians and maintenance crews keeping our airplanes in the air and our family and friends safe in the air. She gave a shout-out to and thanked them for the opportunity and the tour. Vice-Mayor Peck said Go Thunder! Thunder Up Game One Round 2 tonight. She voiced pride for our Thunder team and excitement for round two. Let's rock it! Let's go team!


