

RESOLUTION APPROVING AIRCRAFT PURCHASE AGREEMENT WITH PORTLOCK AVIATION, LLC FOR THE SALE OF A 2014 AIRBUS AS350 B3E HELICOPTER, REVENUE OF \$1,550,000; AND AUTHORIZING THE POLICE CHIEF OR DESIGNEE TO SIGN AIRCRAFT DELIVERY RECEIPT UPON DELIVERY OF THE HELICOPTER TO THE PURCHASER.

WHEREAS, on September 10, 2024 (Item No. IX. K.) Council approved to surplus the Oklahoma City Police Department (OKCPD) 2014 Airbus AS350 B3e Helicopter via Broker Service; and

WHEREAS, on August 27, 2024 (Item No. IX. I.) Council approved to advertise Helicopter Broker Service (OCITY-RFP-25402); and

WHEREAS, on December 3, 2024 (Item No. IX. A.) Council approved awarding the Helicopter Broker Service pricing agreement to Portlock Aviation LLC; and

WHEREAS, the RFP did not include any provisions prohibiting the broker from acting as the buyer, and both the broker and the OKCPD, relying on their independent expertise, have confirmed that the sale price reflects fair market value; and

WHEREAS, the broker clarified that the final sale contract would be between the City and Portlock Aviation, his brokerage company; and

WHEREAS, this arrangement allows the ultimate buyer to address any additional requirements, such as modifications, paint jobs, or parts replacements, directly with the broker, thereby streamlining the process and minimizing the City's involvement in extended negotiations; and

WHEREAS, to the best of the City's knowledge, the broker presented all other offers for consideration; and

WHEREAS, one potential buyer, another law enforcement agency, expressed interest but required a turnkey aircraft equipped with mission-specific tools such as a camera and searchlight; and

WHEREAS, after internal review, it was determined that the current mission equipment would not be included in the sale; and

WHEREAS, as a result, the agency decided not to pursue the purchase, and no formal offer was submitted; and

WHEREAS, OKCPD has received a contract from Portlock Aviation LLC to sell 2014 Airbus AS350 B3e Helicopter for \$1,550,000; and

WHEREAS, as written in the current pricing agreement with Portlock Aviation LLC a contract cannot be accepted before the City of Oklahoma City has approved the sale; and

WHEREAS, OKCPD has stated that this is a fair offer and is requesting City Council approval to finalize the sale of 2014 Airbus AS350 B3e Helicopter; and

NOW, THEREFORE, BE IT RESOLVED by the Council of The Oklahoma City Oklahoma City that they do hereby adopt the Resolution approving Aircraft Purchase Agreement with Portlock Aviation, LLC for the sale of a 2014 Airbus AS350 B3E Helicopter, revenue of \$1,550,000; and authorize the Police Chief or designee to sign Aircraft Delivery Receipt upon delivery of the helicopter to the purchaser.
