XII. Comments from Council

Councilperson Carter wished everyone a Happy New Year.

Councilperson Carter thanked the Rescue Mission, Homeless Alliance, Jodi of Bending Knees, Delisa of Second Chances Thrift Store, Jessica of Sandwiches with Love, Ryan of Project Winter Watch, Victory Church, Church Under the Bridge, and Crossing Church for their efforts to help the unhoused last week during the coldest weather we ever had in the state of Oklahoma. He mentioned he, along with Mark and some of his staff, were able to put 208 people in motel rooms to get them off the streets and out of the weather. He noted the experience of getting that taken care of and seeing everyone come together collectively was amazing. He thanked the citizens of Oklahoma City for doing what they do best by coming together to work for one another.

Councilperson Young gave a shout-out and wished her granddaughter Ruby a happy birthday. She said Mimi loves you and to mind your mama.

Councilperson Young congratulated the Fraternal Order of Police, Lodge 123 on a well negotiated contract on both sides. She encouraged folks to come work for The City of Oklahoma City, and if you already do, we love and appreciate you; be safe out there.

Councilperson Nice mentioned, in light, of the Fraternal Order of Police Lodge 123 contract, that we need to make sure and/or ensure that others are receiving the same benefits when it comes to what we are agreeing to.

Councilperson Nice mentioned she has questions concerning the park for the Capitol View neighborhood. She noted they have located an area for the park, and she would like more information on how we can ensure that this property is obtained in the efforts for this neighborhood to have its park.

Councilperson Nice expressed concerns about safety issues in terms of shootings, parking, unhoused individuals, and lighting in Bricktown. She noted Bricktown is our premier area in terms of MAPS Project investments to bring tourism, attractions, companies, and people in from all over the world to experience what this entertainment district is supposed to be. She mentioned she walked around and took a cruise to experience the lower and part of the upper Bricktown areas after dark this past weekend, and she was scared due to safety and lighting issues; lots of lights were out along the canal in the lower Bricktown area, and some young people were throwing objects at the boat from above. She said having experienced those things as an elected official in these areas, she could not imagine what other folks are experiencing; it's terrifying. She stated she would like us to invest in ways to ensure the safety of our youth due to recent incidents involving those that are under the age of 18, and in lighting for Bricktown in general. She said there must be a better commitment to this area and a long-term recurring investment to ensure we are working on maintaining it. She noted the ride down the canal was very sad, as there are lots of vacant buildings and it is not as vibrant as we would want or need it to be, which is very unfortunate. She said she knows there are quite a few things that must be discussed, but she hopes that we will work on a collective solution and/or plan for the Bricktown area.

Councilperson Nice mentioned she has not received an update on the two lights that she has requested for specific neighborhoods for months. She noted lighting was an issue in the discussion earlier concerning an unsecured and/or abandoned property and in terms of the Bryant Center. She said one of the lights she requested is for an area where a 90-year-old resident resides, and providing it is the least we could do for that senior.

Councilperson Nice mentioned she attended the Oklahoma City Housing Authority meetings for the last couple of months, and in continued talks about the areas and/or properties that are under their purview,

specifically, Creston Park, in which she has been awaiting updates on movement, they now want The City of Oklahoma City to bail them out with \$2,000,000 to fund the gap for this project. She noted funding was available to them, but they had to return it to the state. She said she does not believe the City should have to bail them out for what they did to themselves, as well as for what they did in terms of their tenants, said properties, and miscommunication with the residents of that particular area. She stated it is very unfortunate and unfair that she must address questions for which she has no answers; she is still trying to figure out what the solutions will be. She said she will continue to attend those meetings to ensure that those properties are maintained in the manner that our residents have requested, also considering that they are having some employee issues as well.

Councilperson Stonecipher thanked Chief Gourley for providing him information on real-time information centers, often referred to as real-time crime centers. He said it is a great tool that helps our police officers get to the scene of a crime much quicker. He noted there are currently 120 centers across the United States, and none are fully operational in the state of Oklahoma at this time. He stated the Chief kindly provided him with information on what the City of Fort Worth had done with its budget and real-time crime center. He said he had requested Brent Bryant look at this in terms of what we are trying to implement and what the City of Fort Worth has successfully implemented. He plans to have additional briefings with the Councilmembers, and at some point, he would like to come back to the City Council to talk about expanding the program in the near future. He said he thinks it is a great program, and echoing Mayor Holt's comments, we are short on applicants and need to fill at least 100 or more positions; this is a tool that will help our police force in the interim.

Councilperson Stonecipher reported with the penalty reduction program, the City has now collected \$1.1 million and closed over 9,000 cases. He reminded everyone to go clear their warrants and get a fresh start. He said the program is not going to be around forever, so please take advantage of it.


