Honorable Chairman and Trustees:

I. SCOPE

Amendment No. 1 adjusts plan quantities to match quantities in the field necessary for the completion of the project. Change Order No. 1 adds new pay items to the contract.

II. JUSTIFICATION

Amendment No. 1 adds 500 linear feet of 1" Communication Line and 1,500 linear feet of #2 Electrical Wire to the estimated quantities. During site evaluation, Nash Construction encountered two unknown conduits with electrical supply and communication cables within that are routed to the intake tower on the dam of McGee Creek Lake. The conduits were not documented in the as-builts and were encountered by Nash during trench excavation for the proposed construction. These cables need to be replaced and tied into the new above ground cabinet as part of this project.

Change Order No. 1 adds pay items for 6-Pair Conductor Cables and Cat 6 Cable to the contract. Nash Construction encountered other additional communication and conductor cables that run from the pump station building to the Genset building at the base of the dam. To avoid splicing these cables and risking the increased probability of failures in the future, SRB is recommending that these cables be removed and replaced in their entirety.
