

## **RESOLUTION**

### **RESOLUTION APPROVING A SUBSTANTIAL AMENDMENT TO THE FISCAL YEAR 2024-25 FIFTH YEAR ACTION PLAN, FOR SUBMISSION TO THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT, INCLUDING AUTHORIZING REALLOCATION OF VARIOUS FUNDS; AND AUTHORIZING EXECUTION OF NECESSARY DOCUMENTS.**

**WHEREAS**, The Five-Year Consolidated Plan and Annual Action Plan (the “Plan”) establishes the priorities and programs for use of federal grant funds for community planning and development, including funds for the Community Development Block Grant (CDBG) Program and the HOME Investment Partnerships Program (HOME); and

**WHEREAS**, following annual adoption of the Plan, any significant changes, such as the establishment of a new program and/or an allocation or reallocation of substantial funding, require a Substantial Amendment to the Plan and a public hearing; and

**WHEREAS**, The City desires to reallocate CDBG program funding to the following programs and activities, specifically as set forth below:

- a. The Village on Walnut Development Infrastructure; and
- b. The Strong Neighborhoods Initiative (SNI) Safe and Tidy Program; and
- c. The SNI Hazardous Tree Program; and
- d. The SNI Metro Park Sidewalks Phase III; and
- e. The SNI Capitol Hill Sidewalks Phase IV; and
- f. The SNI Neighborhood Grants; and
- g. The Emergency Home Repair Parallel Pilot Program; and

**WHEREAS**, The City desires to reallocate HOME funding to the following programs and activities, specifically as set forth below:

- a. The construction of affordable housing in the MLK Neighborhood; and
- b. Alley’s End; and
- c. Community Housing Development Organization (CHDO) Program for the construction of affordable housing in The Village on Walnut and Capitol Hill; and

**WHEREAS**, CDBG funds in the amount of \$100,000 have been identified within the Unspecified Public Facility budget to support the financial needs of The Village on Walnut; and

**WHEREAS**, CDBG funds in the amount of \$45,000 have been identified within the SNI Public Services budget to support the financial needs of the SNI Safe and Tidy Program; and

**WHEREAS**, CDBG funds in the amount of \$170,000 have been identified within the SNI Public Services budget and the Unspecified Public Facility budget to support the financial needs of the SNI Hazardous Tree Program; and

**WHEREAS**, CDBG funds in the amount of \$450,000 have been identified within the SNI Public Facilities budget and the Unspecified Public Facility budget to support the financial needs of the SNI Metro Park Sidewalks Phase III; and

**WHEREAS**, CDBG funds in the amount of \$475,250 have been identified within the SNI Public Facilities budget to support the financial needs of the SNI Capitol Hill Sidewalks Phase IV and SNI Neighborhood Grants; and

**WHEREAS**, CDBG funds in the amount of \$325,000 have been identified within the Housing Exterior Maintenance Program budget to support the financial needs of the Emergency Home Repair Parallel Pilot Program; and

**WHEREAS**, HOME funds in the amount of \$2,000,000 have been identified within the Affordable Housing Development Program's Unallocated Fund budget to support the financial needs of SNI MLK New Construction Single Family Homes and CHDO homes; and

**WHEREAS**, allocations in this Substantial Amendment will be available for obligation through the 2025-26 Fiscal Year.

**WHEREAS**, The Mayor is authorized to execute all necessary documents for the amended budgets and funding terms, including but not limited to amended contracts with subrecipients, developers, and contractors.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and City Council of The City of Oklahoma City:

1. The FY 2024-25 Fifth Year Action Plan is hereby amended to reallocate \$100,000 from the Community Development Block Grant (CDBG) General Public Facility line item to Jefferson Park / Positively Paseo The Village on Walnut Development Infrastructure.
2. The FY 2024-25 Fifth Year Action Plan is hereby further amended to reallocate \$45,000 in CDBG funds from SNI Public Services to a new line item for SNI Public Service: Neighborhood Cleanup Safe and Tidy.
3. The FY 2024-25 Fifth Year Action Plan is hereby further amended to reallocate \$170,000 in CDBG funds from SNI Public Services and the Community Development Block Grant (CDBG) General Public Facility line items to a new line item for SNI Public Service: Hazardous Tree Program.
4. The FY 2024-25 Fifth Year Action Plan is hereby further amended to reallocate \$450,000 in CDBG funds from SNI Public Facilities and the Community Development Block Grant (CDBG) General Public Facility line items to a new line item for SNI Public Facilities: Metro Park Sidewalks – Phase III.
5. The FY 2024-25 Fifth Year Action Plan is hereby further amended to reallocate \$450,000 in CDBG funds from SNI Public Facilities line item to a new line


item for SNI Public Facilities: Capitol Hill Sidewalks – Phase IV.

6. The FY 2024-25 Fifth Year Action Plan is hereby further amended to reallocate \$49,250 in CDBG funds from SNI Public Facilities line item to a new line item for SNI Public Facilities: Neighborhood Grants.
7. The FY 2024-25 Fifth Year Action Plan is hereby further amended to reallocate \$325,000 in CDBG funds from OKC Housing Assistance – Exterior Maintenance Program line item to a new activity: Emergency Home Repair Parallel Pilot Program.
8. The FY 2024-25 Fifth Year Action Plan is hereby further amended to reallocate \$400,000 in HOME funds from the AHDP line item to a new activity: SNI MLK New Construction Single Family Homes.
9. The FY 2024-25 Fifth Year Action Plan is hereby further amended to reallocate \$600,000 in HOME funds from the AHDP line item to Alley's End.
10. The FY 2024-25 Fifth Year Action Plan is hereby further amended to reallocate \$1,000,000 in HOME funds from the AHDP line item to the CHDO line item.
11. Allocations in this Substantial Amendment will be available for obligation through the 2025-26 Fiscal Year.
12. The Mayor is authorized to execute all necessary documents for the amended budgets and funding terms, including but not limited to amended contracts with subrecipients, developers, and contractors.


