ORDINANCE NO. 27,602

AN ORDINANCE RELATING TO GENERAL SCHEDULE OF FEES, AMENDING CHAPTER 60 OF THE OKLAHOMA CITY MUNICIPAL CODE, 2020, AMENDING TITLE 12 - BUILDINGS AND BUILDING REGULATIONS, ARTICLE II – BUILDING CODE, BY AMENDING SECTIONS 60-12-6 - BUILDING PLAN REVIEW, 60-12-7 - ALTERATIONS, REMOVAL, REPAIR, 60-12-8 – DEMOLITION FEE, 60-12-9 - NEW CONSTRUCTION, 60-12-10 - MISCELLANEOUS FEES, 60-12-11 - ELEVATORS AND 60-12-12 - HOUSE MOVING; AMENDING ARTICLE IV - FALLOUT OR TORNADO SHELTERS, BY AMENDING SECTION 60-12-24 – FALLOUT OR TORNADO SHELTERS; AND AMENDING ARTICLE VI – INSULATION CONTRACTORS, BY AMENDING SECTION 60-12-35 - INSULATION CONTRACTOR; AND PROVIDING FOR AN EFFECTIVE DATE.

ORDINANCE

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF OKLAHOMA CITY:

SECTION 1. That Sections 60-12-6, 60-12-7, 60-12-8, 60-12-9, 60-12-10, 60-12-11, 60-12-12 of Title 12 of Article II of Chapter 60 of the Oklahoma City Municipal Code, 2020, are hereby amended to read as follows:

SECTION 2: That Section 60-12-24, of Article IV and Section 60-12-35 of Article VI of Title 12 of Chapter 60 of the Oklahoma City Municipal Code, 2020, are hereby amended to read as follows:
