


BOUNDARY SURVEY

Parent Tract

(JOINT TENANCY WARRANTY DEED Book 5753 Page 737 Canadian County, Oklahoma)

A part of the Southwest Quarter (SW/4) of Section FOUR (4), Township TEN (10), North, Range FIVE (5) West of the Indian Meridian, Canadian County, Oklahoma, described as follows: Beginning at a point 880 feet East of the Southwest corner of said Section FOUR (4); Thence North 1584 feet; Thence East 275 feet; Thence South 1584 feet; Thence West 275 feet to the Point of Beginning.

Tract A

A part of the Southwest Quarter (SW/4) of Section FOUR (4), Township TEN (10) North, Range FIVE (5) West of the Indian Meridian, Canadian County, Oklahoma, described as follows:

COMMENCING at the Southwest corner of said Southwest Quarter (SW/4);
Thence N 89°25'32" E, along the South line of said Southwest Quarter (SW/4), a distance of 880.00 feet to the Point of Beginning;
Thence N 89°25'32" E, continuing along said South line, a distance of 150.00 feet;
Thence N 00°34'28" W a distance of 50.00 feet;
Thence N 89°25'32" E a distance of 100.00 feet;
Thence N 00°34'28" W a distance of 841.20 feet;
Thence S 89°25'32" W a distance of 250.00 feet;
Thence S 00°34'28" E a distance of 891.20 feet to the Point of Beginning.

Thence S 00°34'28" E a distance of 1584.00 feet;
Thence S 89°25'32" W, along the South line of said Southwest Quarter (SW/4), a distance of 125.00 feet to the Point of Beginning.
