

**RESOLUTION OF THE OKLAHOMA CITY WATER UTILITIES TRUST RATIFYING THE ACTIONS OF THE GENERAL MANAGER IN DECLARING AN EMERGENCY; WAIVING COMPETITIVE BIDDING, AND AWARDING A CONTRACT TO MATTHEWS TRENCHING COMPANY, INC., PROJECT SE-0057, EMERGENCY SANITARY SEWER REPAIR, 4610 NW 26TH STREET, \$225,500; RATIFYING ISSUANCE OF AN EMERGENCY WORK ORDER; AND APPROVING THE CONTRACT AND BONDS.**

**WHEREAS**, The City of Oklahoma City (Oklahoma City) owns and operates and Oklahoma City Water Utilities Trust (OCWUT) leases and finances the Oklahoma City water system; and

**WHEREAS**, OCWUT purchases equipment and materials necessary for the continuous and efficient operation of the Oklahoma City water system; and

**WHEREAS**, an existing segment of 10-inch clay sanitary sewer pipe had collapsed and needed to be replaced; and

**WHEREAS**, due to the present site condition and the existing sanitary sewer being bypassed, it was deemed beneficial to award the emergency project to Matthews Trenching Company, Inc. (Matthews); and

**WHEREAS**, Matthews has a contract with the Oklahoma City Water Utilities Trust for unit-price sanitary sewer main improvements (SC-1101) that was under construction in the immediate vicinity of the collapsed pipe, and

**WHEREAS**, the proximity and availability of Matthews's equipment and resources saved mobilization time and costs for the emergency project; and

**WHEREAS**, the necessary repairs were beyond the immediate resources of utility crews, and it was in the best interest of the public health, safety, and welfare that repairs be completed immediately so that normal operations could be restored; and

**WHEREAS**, it is in the best interest of the public health, safety, and welfare that repairs be completed immediately so that normal operations can be achieved; and

**WHEREAS**, the General Manager declared an emergency to exist; and

**WHEREAS**, the emergency contract for Project SE-0057 in the amount of \$225,500 was awarded by the General Manager to Matthews Trenching Company, Inc.; and

**WHEREAS**, Matthews Trenching Company, Inc. has signed the contract and bonds for Project SE-0057 for the bid amount of \$225,500; and

**WHEREAS**, the City Engineer issued an emergency work order.

**NOW, THEREFORE, BE IT RESOLVED** by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby ratify the actions of the General Manager in declaring an emergency; waiving competitive bidding, and award a contract to Matthews Trenching Company, Inc, Project SE-0057, Emergency Sanitary Sewer Repair, 4601 NW 26th Street, \$225,500; and






