SUBJECT: Sole Source – LeadsOnline, LLC

LeadsOnline, LLC is a sole source vendor that provides an efficient and secure method of evidence collecting and analyzing over 1.5 billion transactions over 25,000 pawn shops, electronic stores, metal recyclers, eBay, gold buyers, OfferUp.com, and other secondhand stores in all 50 states for investigative purposes.

The LeadsOnline system functionality designed specifically for criminal investigations is the exclusive proprietary property of LeadsOnline and is protected under the United States Copyright Act (17 U.S.C.), as well as by all applicable state and international copyright laws, and by the Lanham Act (15 U.S.C. §§1051-1141n). No other supplier has access to this technology.

LeadsOnline connects the Oklahoma City Police Department to a network of over 5,000 law enforcement agencies throughout Oklahoma and the rest of the United States.

The Police Department wants to renew their sole source contract. The renewal cost has increased from \$98,870.00 to \$119,998.00.

This letter serves as a sole source document for services provided by LeadsOnline, including the Real Time Crime system.

The LeadsOnline system functionality designed specifically for criminal investigations using transaction data from pawnshops, scrap yards, eBay, gold buyers, OfferUp.com and other secondhand stores is the exclusive proprietary property of LeadsOnline and is protected under the United States Copyright Act (17 U.S.C.), as well as by all applicable state and international copyright laws, and by the Lanham Act (15 U.S.C. §§1051-1141n). No other supplier has access to this technology which has been developed over 17 years.

There are many reasons law enforcement agencies conclude that LeadsOnline is the sole source for their criminal investigations system. Key points defining the uniqueness of LeadsOnline for Oklahoma City Police Department include but are not limited to the following:

Not only will OKC PD access information from the vast numbers of reporting businesses, but the LeadsOnline network will continue to grow as major corporations such as Best Buy, ecoATM, Pawn America, etc. continue to expand product lines and open new businesses across America.
