

RESOLUTION AUTHORIZING THE SOLE SOURCE PURCHASE OF SOFTWARE LICENSING AND SUPPORT SERVICES FROM LEADSONLINE, LLC (COKC01525) FOR ACCESS TO PAWN SHOP DATA FOR POLICE INVESTIGATIVE PURPOSES, \$119,998, APRIL 1, 2025 THROUGH MARCH 31, 2026.

WHEREAS, since 2014, the City has maintained this sole source agreement with LeadsOnline, LLC, consistently renewing or readopting it under the same terms and conditions established in the original 2014 agreement; and

WHEREAS, on March 29, 2022 (Item No. IX. G.), City Council approved a readoption of software licensing and support services from LeadsOnline, LLC; and

WHEREAS, this agreement provided access to pawn shop data for police investigative purposes, from April 1, 2022 through March 31, 2023; and

WHEREAS, in March 2023, Oklahoma City entered into a three-year agreement called "Option 1, Straight-lined annual dollar renewal increase" with LeadsOnline, LLC; and

WHEREAS, the agreement discounted the market rate by 18%, saving the City of Oklahoma City \$67,029; and

WHEREAS, the original agreement, effective from April 1, 2023, to March 31, 2024, was priced at \$77,741; and

WHEREAS, the first renewal, covering the period from April 1, 2024, to March 31, 2025, was presented to City Council on March 26, 2024, with an updated price of \$98,870; and

WHEREAS, this is the last and final renewal of the current agreement; and

WHEREAS, LeadsOnline, LLC is the sole source provider of a national web-based database which compiles data of pawned and sold goods from over 28,000 pawnshops, electronics stores, precious metal dealers, metal recyclers and on the eBay website from across the United States; and

WHEREAS, staff requests Council authorize the sole source purchase of software licensing and support services from LeadsOnline, LLC (COKC01525) for access to pawn shop data for police investigative purposes, \$119,998, April 1, 2025 through March 31, 2026; and

WHEREAS, there is a continuing need for these services.

NOW, THEREFORE, BE IT RESOLVED by the Council of The City of Oklahoma City that they do hereby authorize the sole source purchase of software licensing and support services from LeadsOnline, LLC (COKC01525) for access to pawn shop data for police investigative purposes, \$119,998, April 1, 2025 through March 31, 2026.
