## The City of OKLAHOMA CITY

Approve a total allocation of General Obligation Funds in the amount of \$401,790 to Project BC-0241, Unit Price Bridge Contract. Wards 1, 2, 3, 4, 5, 6, 7 and 8.

**Location:**

City-wide

**Background:**

Every year the city has a need to have a contractor available to make necessary infrastructure repairs to City bridges on an as-needed basis. Last year this Committee recommended approval of project BC-0226 for said repairs with unlisted bridge funds from both the 2007 and 2017 General Obligation Bond Authorizations as the source of funding. Based upon that recommendation, City Council awarded a one-year contract extension. That contract extension has now expired with a remaining balance of \$401,790 which staff would like to use for the 2022-2023 bridge repair contract. This allocation request transfers the remaining balance from the expired unit price bridge contract BC-0226, to the new unit price contract, BC-0241. This contract is used city-wide for the replacement and rehabilitation of bridges.
