

RESOLUTION AUTHORIZING THE SOLE SOURCE PURCHASE OF HARDWARE, SOFTWARE MAINTENANCE, LICENSES, TRAINING, UPDATE SERVICES, AND APPLICATION SUPPORT FOR THE AXON EVIDENCE DATA MANAGEMENT SYSTEM FROM AXON ENTERPRISES, INC. (COKC00026) ESTIMATED COST \$300,000, JUNE 7, 2024 THROUGH JUNE 6, 2025.

WHEREAS, on September 14, 2021 (Item No. IX.BW), the City of Oklahoma City approved a Master Services and Purchasing Agreement with Axon Enterprise Inc. to provide an Integrated Police Data Management System that includes hardware such as body worn cameras, conductive electrical weapons (Taser), fleet vehicle cameras, software and update services; and

WHEREAS, as part of the Police Headquarters building project, Axon Evidence Data Management System (Axon System) was implemented; and

WHEREAS, the Axon System allows the Oklahoma City Police Department (Police) to stream interviews from anywhere on the City of Oklahoma City's Network, bookmark, annotate and comment on interviews in real time; and

WHEREAS, the holding and interview rooms at Criminal Interdiction Team of Central Oklahoma (C.I.T.C.O) and at Will Rogers World Airport (Airport) has audio and video equipment from another system that is outdated and no longer being supported; and

WHEREAS, this has resulted in recordings being lost and evidence being unable to be submitted; and

WHEREAS, the upgrade to the Axon System has brought both the C.I.T.C.O and the Airport rooms up to date with the current software, creating compatibility across all Interview and Evidence Systems used by Police; and

WHEREAS, hardware, software maintenance, licenses, training, update services, and application support for the Axon System is proprietary to Axon Enterprise Inc.; and

WHEREAS, these services are essential to recording and storing digital evidence; and

WHEREAS, staff requests Council authorization for the sole source purchase of hardware, software maintenance, licenses, training, update services, and application support for the Axon

Evidence Data Management System available through Axon Enterprises, Inc. (COKC00026) estimated cost \$300,000, June 7, 2024 through June 6, 2025; and

WHEREAS, there is a continuing need for the procurement of this commodity.

NOW, THEREFORE, BE IT RESOLVED by the Council of The City of Oklahoma City that they do hereby authorize the sole source purchase of hardware, software maintenance, licenses, training, update services, and application support for the Axon Evidence Data Management System available through Axon Enterprises, Inc. (COKC00026) estimated cost \$300,000, June 7, 2024 through June 6, 2025.
