

AMENDMENT NO. 1

This Amendment No. 1 is entered into and made effective as of JANUARY 2, 2024, (the "Effective Date") by and between Digital Markets, Inc, (dba Vista Com) and The City of Oklahoma City, a municipal corporation (hereinafter referred to as "City").

WHEREAS, on August 1, 2017, Vista Com and City entered into an Agreement for Products and Services for the replacement of the public safety grade Advanced Call Logging and Recording System to the Eventide system; and

WHEREAS the services under the Agreement were provided by Vista Com for an initial four-year period with the option to renew for four additional one-year periods; and

WHEREAS the Agreement has been renewed annually with the most recent renewal being completed on July 18, 2023 (Item No. IX. BQ); and

WHEREAS the parties desire to amend the Agreement to add the purchase of a Nexlog 740DX Upgrade, quoted by Vista Com on Quote # HOU004774, to upgrade/replace the existing six (6) year old Eventide recorder with the new Eventide Nexlog 740DX solution.

NOW THEREFORE, the parties agree as follows:

1. Exhibit A-1 shall be modified to add the Nexlog 740DX Upgrade to upgrade/replace the existing five (5) year old Eventide recorder with the new Eventide Nexlog 740DX solution.
2. Except as expressly modified by this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
