Joint Resolution with the Oklahoma City Municipal Facilities Authority authorizing the Risk Manager and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. 2022-0005194 styled: *Caleb Anderson, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

### **Background:**

The Claimant, Caleb Anderson is 37 years old and a 9-year employee of The City of Oklahoma City. At the time of the injury he was assigned to the Fire Department as a Sargent/Apparatus Driver and continues to be employed by the City.

Claimant sustained an undisputed accidental injury on February 10, 2022 to his left shoulder. The Claimant required surgery to his left shoulder on June 6, 2022.

Claimant was evaluated by Dr. William D. Jones on behalf of the City and found to have the following permanent partial impairment: left shoulder 11%. The negotiated Joint Petition Settlement calls for a PPD award of \$14,256 for the following permanent partial disability: left shoulder 11%. The settlement includes a payment of \$500, for additional consideration for a total award of \$14,756.

The settlement further calls for a 3% assessment of the PPD award, less the payment of the additional payment amount, in the sum of \$427.68 be deducted and paid on behalf of the claimant for the Multiple Injury Trust Fund Tax, making the lump sum award, including the additional payment, \$14,328.32. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, including the additional payment, shall be paid in the sum of \$110.67 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, less the additional payment, shall be paid in the sum of \$285.12.
