XII. Comments from Council

Councilperson Cooper spoke about Bayard Rustin, a gay civil rights activist who was an advisor or right-hand man to Dr. Martin Luther King, Jr., and the organizer behind the 1963 March on Washington. He mentioned a movie called "Rustin" is available on Netflix, and he anticipates there will be some Oscar nominations for it.

Councilperson Cooper thanked the councilmembers who reached out to him, expressing their concern for his mother, who fell and fractured her wrist. He noted this experience has taught him to be grateful for the things that are in front of us, how to move from desiring more and envying what other people have, and how to find gratitude for the coffee in the morning and the people in our lives. He hopes to take this into account for the rest of this year.

Councilperson Hinkle thanked Debi Martin, Debbi Miller, and David Todd for attending his community forum; it was a good turnout.

Councilperson Hinkle thanked the boy scouts for attending the meeting and staying to listen and see how City government works.

Councilperson Nice echoed Councilperson Hinkle's remarks to the boy scouts.

Councilperson Nice wished everyone a Happy New Year and Kwanzaa.

Councilperson Nice reminded everyone of the events that are happening to commemorate the legacy of Dr. Martin Luther King, Jr. The theme for this year is "Together We Rise: One Nation, One Dream." She mentioned that Oklahoma City has the third largest Martin Luther King, Jr., Day parade in the United States and that we are special, as we hosted Dr. King when he was young but turned him away from being a pastor at Calvary Baptist Church. She noted the following year, after Dr. King's passing, his father commemorated the first Martin Luther King, Jr. program, which is still going strong today. She announced that on January 13th, there will be a gospel extravaganza; on January 14th, the St. John Missionary Baptist Church program will begin at 3:00 p.m.; and at 6:00 p.m., the National Association for the Advancement of Colored People, Oklahoma City Branch, will host a cross-cultural

dinner and program at Temple B'nai Israel; and on January 15th, there will be a prayer breakfast, a job fair, and at 2:00 p.m., the Martin Luther King, Jr. Holiday Parade will begin. Please visit okcmkalliance.org for information about the events. She said volunteers and sponsors are needed, and she encouraged anyone who could to consider being a part of it.

Councilperson Stonecipher thanked Steve Lackmeyer for his great article last Friday on the health, stability, and growth of the economy in Oklahoma City. He reported that wages are up 5.8% over the prior year; unemployment is down to less than 3%; retail sales have rebounded since the pandemic; and housing is more affordable compared to most of the country. He noted that Forbes Magazine named Oklahoma City the second-best place to buy a home. The median age in Oklahoma City is going down, which means that our young people are staying here for jobs and not going to other cities. He said occasionally we should look at what we are doing in terms of having a healthy economy, and he encouraged everyone to read the article; it speaks well of Oklahoma City.


