

JOINT RESOLUTION APPROVING RENEWAL #1 OF PURCHASE OF SERVICES AGREEMENT WITH ALLIANCE WORK PARTNERS, THE OKLAHOMA CITY MUNICIPAL FACILITIES AUTHORITY, AS THE PUBLIC ENTITY CONTRACTING WITH ALLIANCE WORK PARTNERS, ON BEHALF OF THE CITY OF OKLAHOMA CITY, TO PROVIDE AN EMPLOYEE ASSISTANCE PLAN; FOR ELIGIBLE EMPLOYEES AND THEIR ELIGIBLE DEPENDENTS, AND ELIGIBLE EMPLOYEES AND THEIR ELIGIBLE DEPENDENTS OF PARTICIPATING PUBLIC TRUSTS; SUBJECT TO ANNUAL FISCAL APPROPRIATION BY THE COUNCIL FOR THE CITY OF OKLAHOMA CITY, ESTIMATED ANNUAL COST \$175,000, EFFECTIVE JANUARY 1, 2025 THROUGH DECEMBER 31, 2025.

WHEREAS, On December 19, 2023 (Item No. MFA.G.) the Oklahoma City Municipal Facilities Authority (OCMFA) and the City Council approved an Purchase of Services Agreement (“Agreement”) between the OCMFA and Alliance Work Partners, a division of Workers Assistance Program, Inc., to provide employee assistance program services to The City of Oklahoma City and participating public trusts and their eligible employees and eligible dependents; and

WHEREAS, the Agreement contains terms and options to renew for additional one (1) year periods, up to four (4) renewals, for a period not to extend past December 31, 2028; and

WHEREAS, Alliance Work Partners, a division of Workers Assistance Program, Inc. agrees to exercise the one-year renewal option (“Amendment No. 1”) and continue the Purchase of Services Agreement for plan year 2025; and

WHEREAS, the amended agreement includes a zero percent increase rate renewal; and

WHEREAS, staff has determined that the current Agreement with Alliance Work Partners, meets the criteria for the renewal of contracts for goods and services established by the City’s policy, and renewal of the Agreement; and


NOW, THEREFORE BE IT RESOLVED by the Council for the City of Oklahoma City, as sole beneficiary of the Oklahoma City Municipal Facilities Authority, that the Authority, on behalf of The City of Oklahoma City, is hereby authorized to renew the Agreement with Alliance Work Partners, a division of Workers Assistance Program, Inc., to provide employee assistance program services for The City of Oklahoma City, year 2 estimated cost \$175,000, effective January 1, 2025 through December 31, 2025; and

BE IT FURTHER RESOLVED by the Council for The City of Oklahoma City and the Trustees of the Oklahoma City Municipal Facilities Authority that the renewal of the Agreement with Alliance Work Partners, a division of Workers Assistance Program, Inc., is hereby approved subject to annual appropriation by the Council; and

BE IT FURTHER RESOLVED by the Trustees of the Oklahoma City Municipal Facilities Authority that the Chairman, or his designee is hereby authorized and directed to sign and execute renewal (“Amendment No. 1”) of the Agreement with Alliance Work Partners, a division of Workers Assistance Program, Inc.






