I. SCOPE

Change Order No. 4 adds new pay items to the contract.

II. JUSTIFICATION

Change Order No. 4 adds pay items for the additional work to incorporate Change Order Request 6 into the project.

Change Order Request 6 is a response to Architectural Supplemental Instruction 5. This Architectural Supplemental Instruction added to the length of the westward drive in front of south most apparatus bay at the request of the Fire Department.

Change Order No. 4 is an increase of \$28,572.50 or 0.38% above the original contract amount. Change Order Nos. 1 through 4 represent an increase of \$434,391.09 or 5.73% above the original contract amount. The revised contract amount is \$8,021,891.09.

V. CONTRACT TIME

The original contract called for project completion by April 15th, 2025. Change Orders 1 through 3 previously moved the project completion to June 20, 2025. As part of this change order ten (10) additional days were requested. The total contract duration is now changed by this change order. The project completion date is now June 30, 2025.
