Honorable Chairman and Trustees:

I. SCOPE

Amendment No. 1 adjusts plan quantities to match quantities in the field necessary for the completion of the project.

II. JUSTIFICATION

Changes in quantities reflect final measured amounts compared to initial design estimates. Amendment No. 1 adds an additional 116.24 CY of sludge removal and disposal. Based on the measurements of sludge within the tank prior to the removal process, there were 416.89 CY of sludge in the south tank and 741.35 CY of sludge in the north tank. Collectively, a total of 1,158.24 CY of sludge was removed and disposed of during this project.
