

**SERVICE AGREEMENT BETWEEN THE CITY OF  
OKLAHOMA CITY AND THE OKLAHOMA STATE FAIR**

**THIS AGREEMENT** is made between The City of Oklahoma City, a municipal corporation, hereinafter referred to as “City”, and the Oklahoma State Fair, upon execution of the parties and pursuant to the terms stated herein.

**WHEREAS**, the City, through its Fire Department, employs individuals certified as Emergency Medical Technicians (EMTs) and Paramedics; and

**WHEREAS**, the parties to this Agreement desire the City to provide emergency medical services during the annual Oklahoma State Fair (September 12 – 22, 2024).

**NOW, THEREFORE**, in consideration of the mutual covenants and promises set forth herein, the parties agree as follows:

I. **CONSIDERATION, DUTIES AND RESPONSIBILITIES OF EACH PARTY**

a. **CITY**

- i. The City will provide employees certified as EMTs and Paramedics at the Oklahoma State Fair during its operating hours to perform field patient care for those who incur injuries while at the State Fair;
- ii. The City will transport individuals needing greater medical attention to the gates of the fairgrounds so the individual can be transferred to an ambulance;
- iii. The City will also provide a tactical dispatcher, supervisor, and necessary supplies during the duration of the State Fair;
- iv. The City will provide additional paramedics on-site during the bull riding events (September 20 – 21, 2024);
- v. The City shall have complete control over the manner and method of assignment of Fire Department personnel to provide the services detailed in subsections i-iv.

b. **Oklahoma State Fair**

- i. Oklahoma State Fair agrees to pay the City \$70,554.00 for work to be performed by City personnel according to the attached schedule under the terms of this agreement;

- ii. Oklahoma State Fair shall release and indemnify The City of Oklahoma City for any loss resulting from its torts or the torts of any its employees and/or any third party.

II. TERM

This Agreement shall become effective upon the date of approval by The City Council of The City of Oklahoma City and the Oklahoma State Fair and executed by the proper officers of each entity, and shall remain in effect through September 22, 2024, or until terminated by mutual consent of either party with or without cause by giving thirty (30) days written notice.

III. NOTICES

- a. Notice of termination required under this Agreement under “Termination” shall be in writing, shall be considered received when mailed, and shall be mailed by certified mail, return receipt requested, to the parties at the following addresses:

- b. The provisions of this agreement are severable. In the event any of the provisions of this Agreement are judicially determined to be unenforceable, then those terms shall be severed from the agreement and not affect the legality of this Agreement as a whole.

IV. COMPLETE AGREEMENT

This Agreement is the complete agreement of the parties regarding matters addressed herein. No oral agreements or representations shall be considered binding on the parties.


