WHEREAS, these pricing agreements were originally awarded June 20, 2023 (Item No. IX. W) for the period ended June 30, 2024; and

WHEREAS, pricing agreements are being renewed for the period ending June 30, 2025; and

WHEREAS, staff requests open market authority for the purchase of rental of construction, grounds and generator/lighting equipment no bid items (see attachment) and related items and services not available on a pricing agreement (COKC00486), estimated cost \$75,000, retroactive to July 1, 2024 through June 30, 2025; and


WHEREAS, purchases made with this authority will comply with the City's open market purchasing procedures; and

WHEREAS, individual purchases exceeding \$50,000 under this open market resolution will be approved by the City Council through a separate agreement or resolution; and



WHEREAS, there is a continuing need for the purchase of this commodity.
