RENEWAL NO. 1 of Lease Agreement

(COTPA 244124) Bradford & Wilson PLLC

For Leased Premises at 431 W. Main Street, Suite D, Oklahoma City, OK 73102

This renewal (“**Renewal No. 1**”) is made by and between **Bradford & Wilson PLLC** (“**TENANT**”) and the **Central Oklahoma Transportation and Parking Authority** (“**LANDLORD**”), an Oklahoma public trust, (collectively, the “**Parties**”).

WITNESSETH

WHEREAS, on April 6, 2018, **LANDLORD** entered into a lease agreement (“**Lease**”) with The Lanier Law Firm, P.C., for the leased premises at 431 W. Main Street, Suite D, Oklahoma City, OK 73102; and

WHEREAS, the initial term of the **Lease** was for five (5) years and had an effective date of January 15, 2019, with an end date of January 14, 2024; and

WHEREAS, on September 4, 2020, **LANDLORD** agreed to an assignment of the **Lease** from The Lanier Law Firm, P.C. to the current **TENANT** (Bradford & Wilson PLLC); and

WHEREAS, **Paragraph 2. Term** of the **Lease** provides that the **Parties** shall have the option to renew the **Lease** for up to three (3) additional five-year Renewal Terms upon written agreement of both **Parties**; and

WHEREAS, the **Parties** hereby mutually agree to renew the **Lease** under the same terms, conditions and provisions as originally executed.

NOW THEREFORE, it is mutually agreed by and between the **Parties** to renew the **Lease**, exercising the first of three Renewal Terms, under the same terms, conditions and provisions as originally executed, including incremental price increases.
