

RESOLUTION

A RESOLUTION OF THE COUNCIL OF THE CITY OF OKLAHOMA CITY ESTABLISHING A DATE FOR THE PROPOSED ENACTMENT OF AN ORDINANCE CLOSING A PUBLIC WAY OR EASEMENT, DETERMINING THOSE ENTITLED TO NOTICE OF SAME, AND DIRECTING THAT SAID NOTICE BE ISSUED.

WHEREAS, an application to close the following described public way or easement has been considered by the Planning Commission of The City of Oklahoma City as part of a Master Plan or amendment of same, to-wit:

Beginning One (1) foot west of the Northwest Corner (NW/C) of Lot Twenty-Seven (27), in Block Forty-Seven (47), Oklahoma City Original Addition and proceeding East (151) feet to the Northeast corner (NE/C) of Lot Thirty-Two (32), Thence (140) feet South to the Southeast (SE/C) of Lot Thirty-Two (32), Thence (21) feet West, Thence one (1) foot seven (7) inches South, Thence (23) feet East, Thence (143) feet and seven (7) inches North, Thence West (153) feet, Thence South two (2) feet to beginning.

Such notice shall state that an ordinance to close the aforesaid public way or easement has been proposed for enactment on the 8TH day of OCTOBER, 2024. A copy of the resolution shall be included with said written notice.
