

RESOLUTION AUTHORIZING THE PURCHASE OF FIREFIGHTING PERSONAL PROTECTIVE EQUIPMENT AND RELATED EQUIPMENT THROUGH A COOPERATIVE AGREEMENT WITH SOURCEWELL (COKC00498), ESTIMATED COST \$1,500,000, JULY 30, 2024 THROUGH JULY 29, 2025; AND AUTHORIZING THE OPEN MARKET PURCHASE OF RELATED ITEMS AND SERVICES NOT AVAILABLE ON AN AGREEMENT (COKC00499), ESTIMATED COST \$75,000, JULY 30, 2024 THROUGH JULY 29, 2025.

WHEREAS, the Fire Department has a continuing need to purchase firefighting personal protective equipment and related equipment which is available through Sourcewell; and

WHEREAS, Sourcewell benefits public agencies by providing national pricing through competitively solicited proposals; and

WHEREAS, this contract adoption will allow the Fire Department to purchase firefighting personal protective equipment at a discounted price under Sourcewell's contract, Firefighting Personal Protective Equipment with Related Equipment Cleaning #010424; and

WHEREAS, discounts range from 5-45% off current MSRP/List price; and

WHEREAS, the estimated cost for this agreement is the total budget available under the Fire Department's personal protective equipment program; and

WHEREAS, the total will be spent between this agreement and another cooperative agreement which will be presented to Council; and

WHEREAS, staff will consider delivery timeline and price when utilizing the cooperative agreements; and

WHEREAS, the City is under no obligation to purchase from this agreement; and

WHEREAS, all purchases are subject to future appropriations and the availability of funds; and

WHEREAS, staff requests open market authority for the purchase of firefighting personal protective equipment related items and services not available on contract, estimated cost \$75,000, July 30, 2024 through July 29, 2025; and

WHEREAS, purchases made with this authority will comply with the City's open market purchasing policies; and

WHEREAS, there is a continuing need for the procurement of these items.


NOW, THEREFORE, BE IT RESOLVED by the Council of The City of Oklahoma City that they do hereby authorize the purchase of firefighting personal protective equipment and related equipment through a cooperative agreement with Sourcewell (COKC00498), estimated cost \$1,500,000, July 30, 2024 through July 29, 2025; and authorizing the open market purchase of related items and services not available on an agreement (COKC00499), estimated cost \$75,000, July 30 2024 through July 29, 2025.
