## The City of OKLAHOMA CITY

Joint Resolution with the Oklahoma City Municipal Facilities Authority authorizing the Director of Risk Management and the Trust's legal counsel not to appeal and to comply with the Order of the Workers' Compensation Commission Claim No. CM3-2024-04177M, styled: *Ryan Hames, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and authorizing the Municipal Counselor to assist said counsel in the rendition of the Order to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

### **Background:**

The Claimant, Ryan Hames is 41 years old and a 3-year employee of The City of Oklahoma City. At the time of the injury he was assigned to the Fire Department as a Recruit and continues to be employed by the City.

The Claimant sustained an undisputed accidental injury on August 13, 2023 to his right hip. The Claimant required surgery to his right hip on December 29, 2023.

The Claimant was evaluated by Dr. Lance E. Rosson on behalf of his attorney and found to have the following permanent partial impairment: right hip 25%. The Claimant was also evaluated by Dr. Robert Griffith on behalf of the City and found to have the following permanent partial impairment: right hip 1%. On February 4, 2025, Judge P. Blair McMillin, of the Workers' Compensation Commission, awarded Claimant the following permanent partial disability: right hip 14%, entitling Claimant to 50.40 weeks of compensation at \$360 per week, totaling \$18,144. As of February 4, 2025, the amount of said award was fully accrued at \$18,144.

The settlement further calls for a 3% assessment of the PPD award in the sum of \$544.32 be deducted and paid for the Multiple Injury Trust Fund Tax, making the lump sum award \$17,599.68. The Court further ordered \$3,628.80 or 20% of the PPD award be deducted from the award and paid in a lump sum to the Claimant's attorney as a fair and reasonable fee. In addition, the City will pay Court costs \$140, a Special Occupational Health and Safety Tax Fund, representing .75% of the permanent partial disability award in the sum of \$136.08 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award in the sum of \$362.88.
