

AMENDMENT NO. 3 TO CONTRACT FOR ENGINEERING SERVICES

This amendment is made and entered into this 30TH day of JANUARY, 2024, by and between The City of Oklahoma City, a municipal corporation, herein called "City", and Smith Roberts Baldischwiler, LLC, herein called "Engineer".

WITNESSETH:

WHEREAS, the City and the Engineer entered into an agreement on February 8, 2021 as follows:

Project Nos. PC-0703, Street Enhancements,
and PC-0727, Street Resurfacing; and

WHEREAS, the City engaged the services of the Engineer to provide for design and all other engineering services related to street enhancements and resurfacing, "Auto Alley" area along North Broadway Avenue from NW 4th Street to West Park Place; and

WHEREAS, subsequent to execution of the original contract, it was determined to be in the best interest of the City to direct the Engineer to conduct a full traffic study along North Broadway Avenue, from NW 4th Street extending three additional blocks north of the project area to NW 13th Street; and

WHEREAS, the work above was authorized under the auspices of **Amendment No. 1**; and

WHEREAS, the original contract provided for a conceptual plan which included the "Auto Alley" Corridor from NW 4th Street to West Park Place, with initial improvements to be designed from NW 7th Street to NW 10th Street; and

WHEREAS, subsequent to the execution of the original contract as previously amended, and upon completion and submittal of the conceptual plan, it was determined to extend the initial area for street enhancements to include NW 4th Street to West Park Place along North Broadway Avenue (Project PC-0703); and

WHEREAS, the Engineer was required to provide additional coordination with stakeholders, additional topographic survey, traffic signal modifications, design, and final plans for the additional enhancements; and

WHEREAS, the work above was authorized under the auspices of **Amendment No. 2**; and

WHEREAS, subsequent to the execution of the original contract as previously amended, it has been determined to be in the best interest of the City to direct the Engineer to provide design services for three bid alternates to be incorporated into Project PC-0703; and

WHEREAS, the base bid will include the improvements along Broadway Avenue, from NW 6th Street to NW 10th Street; Alternate 1 includes NW 5th Street to NW 6th Street; Alternate 2 includes NW 4th Street to NW 5th Street; and Alternate 3 includes NW 10th to Broadway Circle/Park Place; and

WHEREAS, the Engineer will also be required to perform driveway closure research, attend meetings with property owners and stakeholders, and prepare additional presentation documents related to the alternates; and

WHEREAS, services for driveway closure research, meetings attendance, and preparation of additional presentation documents will be authorized by a separate work order utilizing available funds from the original contract provided in Exhibit E – Additional Services; and

WHEREAS, the original contract must be amended to provide for the Engineer’s increased scope of work as outlined above and associated fees; and

WHEREAS, the total compensation to be paid to the Engineer for this Contract and Amendment shall be as follows:

For the original contract:

Not to exceed \$246,049 for engineering services

For Amendment No. 1:

Not to exceed \$30,504 for engineering services

For Amendment No. 2:

Not to exceed \$119,548 for engineering services

For Amendment No. 3:

Not to exceed \$48,000 for engineering services

Total Amended Contract:

Not to exceed \$444,101 for all services (an increase of \$48,000); and

WHEREAS, both parties agree to amend said contract.

NOW, THEREFORE, the parties agree as follows:

- I. Amend **Paragraph 2. Basic Services.** to read as follows:

Basic Services. The Engineer is hereby engaged and employed by the City to perform in accordance with good engineering practices and in the best interest of the City in accordance with the professional standard of care all of the work as set out herein (including **Amendment No. 1** work related to conducting a traffic study along North Broadway Avenue from NW 4th Street to NW 13th Street; and **Amendment No. 2** work related to additional coordination with stakeholders, topographic survey, traffic signal modifications, design, and final plans for street enhancements in the extended project area for PC-0703; and **Amendment No. 3** work related to design services for three bid alternates to be incorporated into the project); and including Exhibit A, and including but not limited to the following:

II. Amend **Paragraph 5. Compensation.** to read as follows:

Compensation. The aggregate total compensation for all engineering services under this Contract shall not exceed a total fee of \$444,101 (an increase of \$48,000), which includes: for Basic Services an amount not to exceed \$419,124 (an increase of \$48,000) as specifically set forth in Exhibit B, attached hereto and incorporated herein; and, for Additional Services an amount not to exceed \$24,977, as specifically set forth in Exhibit E attached hereto and incorporated herein.

III. Amend **EXHIBIT A – SCOPE OF WORK** by addition of the following “**Exhibit A – Scope of Work (added by Amendment No. 3)**”:

Task 2 - Final Construction Plans

1. The development of a Bid Alternate #1 to which includes the block along Broadway Avenue between N.W. 5th Street and N.W. 6th Street.
 - a. This will require the design of an alternate project termination and tie-in that will need to be shown in the plans. Alternate Bid Items separated within the Bid Item summary.
 - b. Separate sheets which had originally been included in the bid, with new transitions and drawings with show the project termination points.
2. The development of a Bid Alternate #2 which will include consistent improvements to the block along Broadway Avenue between N.W. 4th Street (with matching transition to the south) and N.W. 5th Street.
 - a. This will require the design of an alternate project termination and tie-in that will need to be shown in the plans. Alternate Bid Items separated within the Bid Item summary.
 - b. Separate sheets which had originally been included in the bid, with new transitions and drawings with show the project termination points.

3. The development of Bid Alternate #3 which will include the blocks along Broadway Avenue between N.W. 10th Street and Circle/Park Place.
 - a. This will require the design of an alternate project termination and tie-in that will need to be shown in the plans. Alternate Bid Items separated within the Bid Item summary.
 - b. Separate sheets which had originally been included in the bid, with new transitions and drawings with show the project termination points.

Task 3 – Bidding Services

Separate bid item within bid form, evaluation of bids by contractors for each alternate.

Task 4 – Construction Administration Services

Management of bid items within the contract administration for selected alternate(s).

IV. Amend **EXHIBIT B – COMPENSATION** to read as follows:

**EXHIBIT B
COMPENSATION
PROJECT NOS. PC-0703, STREET ENHANCEMENTS,
AND PC-0727, STREET RESURFACING**

Under the terms of this Contract, the Engineer agrees to perform the work and services described in this Contract. The City agrees, in accordance with the limitations and conditions set forth in the Contract, to pay an amount not to exceed \$444,101 (an increase of \$48,000) which includes: for Basic Services an amount not to exceed \$419,124 (an increase of \$48,000), as specifically set forth in this Exhibit B; and, for Additional Services an amount not to exceed \$24,977 as specifically set forth in Exhibit E.

**B.I. Basic Work and Services
Project PC-0703**

Compensation for basic services may not exceed \$370,899 (an increase of \$48,000), and in no event may the Engineer receive compensation in excess of the amount listed for each task for performance of its basic services.

The Engineer may receive up to the following amounts of the not to exceed amounts for services rendered upon the completion of the following tasks. Partial payments of the not to exceed amounts for each task may be invoiced for incremental work completed. Not to exceed amounts below are accumulative for successive tasks.

Task 1 an amount not to exceed:
\$97,979

Completion and recommendation by the City Engineer for approval by the City of the Preliminary Report for the project.

Task 2 an additional amount not to exceed:
\$207,135 (an increase of \$45,500)

Completion and acceptance by the City of the final plans and specifications for the project.

Task 3 an additional amount not to exceed:
\$12,737 (an increase of \$1,500)

Award of the construction contract to the successful Bidder.

Task 4 an additional amount not to exceed:
\$47,320 (an increase of \$1,000)

Upon completion and final acceptance by the City of the completed project. Said amount is to be paid proportionately to the level of completion of project construction. The proportionate amount is to be consistent with

the Construction Contractor's percentage of completion.

Task 5 an additional amount not to exceed:
\$5,728

Upon satisfactory completion and acceptance of the project as-built drawings.

**B.II. Basic Work and Services
Project PC-0727**

Compensation for basic services may not exceed \$48,225, and in no event may the Engineer receive compensation in excess of the amount listed for each task for performance of its basic services.

The Engineer may receive up to the following amounts of the not to exceed amounts for services rendered upon the completion of the following tasks. Partial payments of the not to exceed amounts for each task may be invoiced for incremental work completed. Not to exceed amounts below are accumulative for successive tasks.

Task 1 an amount not to exceed:
\$10,375

Completion and recommendation by the City Engineer for approval by the City of the Preliminary Report for the project.

Task 2 an additional amount not to exceed:
\$20,695

Completion and acceptance by the City of the final plans and specifications for the project.

Task 3 an additional amount not to exceed:
\$2,851

Award of the construction contract to the successful Bidder.

Task 4 an additional amount not to exceed:
\$12,710

Upon completion and final acceptance by the City of the completed project. Said amount is to be paid proportionately to the level of completion of project construction. The proportionate amount is to be consistent with the Construction Contractor's percentage of completion.

Task 5 an additional amount not to exceed:
\$1,594

Upon satisfactory completion and acceptance of the project as-built drawings.

IT IS UNDERSTOOD AND AGREED BY AND BETWEEN the City and the Engineer that, as amended by this Instrument, all terms and conditions of the original Contract shall remain in full force and effect and the provisions of this Instrument shall become a part of the original Contract as if fully written herein.
