## The City of OKLAHOMA CITY

Joint Resolution with The City of Oklahoma City authorizing the Risk Manager and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM- (to be determined) styled: *Todd Reese, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

### **Background:**

The Claimant, Todd Reese is a 66-year-old male and is a seven-year employee of The City of Oklahoma City. At the time of the injury, he was assigned in the Parks Department as a Parks and Grounds Superintendent. Claimant retired from the City on July 8, 2022.

On March 24, 2020, the Claimant sustained an undisputed accidental injury to his left shoulder.

The Claimant required surgery to repair his left shoulder on August 3, 2021.

Claimant was evaluated by Dr. Ryan L. Nelson, D.O. on behalf of the City and found to have the following permanent partial impairment: 6% to the left shoulder.

The negotiated Joint Petition Settlement calls for a lump sum of \$12,600 for the following permanent partial disability: 10% to the left shoulder. The settlement includes a payment of \$500, for additional consideration for a full, final, and complete settlement, for a total award of \$13,100.

The settlement further calls for a 3% assessment of the PPD award, less the payment of the additional payment amount, in the sum of \$378 be deducted and paid for the Multiple Injury Trust Fund Tax, making the lump sum award, including the payment, \$12,722. In addition, the City will pay Court costs of \$140; a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, including the additional payment, shall be paid in the sum of \$98.25; and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, less the additional payment, shall be paid in the sum of \$252.
