Honorable Mayor and Council:

I. SCOPE

Change Order No. 4 includes the modification of providing power to the Safe Room shutters, the relocation of the gas riser, the inclusion of concrete stoops at exterior Patio doors, the addition of circuits at floor boxes, a revised finish for the chain link fence, the inclusion of a column to support interior signage and (11) eleven weather days.

II. JUSTIFICATION

Change Order No. #4 includes **Item 1**; includes providing power to (2) two shutters, LV-3 and LV-4 at the Staff Breakroom 044, which serves as the Safe Room. Power is to be provided to eliminate the risk of the louver not being operable in the case of battery failure. **Item 2**; includes the relocation of the gas riser to allow for HVAC unit disconnects to achieve required clearances. **Item 3**; includes providing (2) two concrete stoops at the Patio exterior doors to allow improved egress in lieu of artificial turf. **Item 4**; includes providing additional circuits at floor boxes serving computer stations. This work will result in an additional (2) two days added to the original contract date. **Item 5**; includes providing a new powder coated painted finish to all posts, gates and chainlink fabric surrounding the mechanical pad. This work will result in an additional (7) seven days added to the original contract date. **Item 6**; includes providing a W24x55 painted steel column to support the 'Teens' interior signage. **Item 7**; includes a revised finish for the chainlink fence. The finish is to be powder coated black. **Item 8**; includes the addition of (11) eleven days to the contract due to weather days occurring from September 2023 to January 2024.

Revised Contract Amount \$6,775,407.84

Change Order No. 4 is an increase of \$33,619.00 or 0.51% above the original contract amount. Change Order No. 1 through Change Order No. 4 represent an increase of \$121,407.84 or 1.82% of the original contract amount. The revised contract amount is \$6,775,407.84.

Change Order No. 4 is an increase of 20 days to the contract. The completion date is January 25, 2024.
