XII. Comments from Council

Councilperson Carter thanked the Public Transportation and Parking Director and Assistant City Manager Jason Ferbrache, Suzanne Wickenkamp, Jesse Rush, Cody Boyd, Kharlie Barnaby, Marilyn Dillon, Dennis Fry, Kristen Torkelson, Byron Richmond, and Joe Garcia for providing him and his family with a tour and the history of their operations and a ride on the new Bus Rapid Transit last week, and for all they do to serve our city with little to no recognition; he was impressed.

Councilperson Carter gave a shout out to the Oklahoma City Fire Department in Ward 1, as he was extremely impressed with the way they handled the house fire in his neighborhood, the community, and the family who unfortunately lost their home. He thanked them for their quick response and actions, and all they do for us usually without thanks; and he especially thanked the new neighbor who went in and got the people out of their home and provided them assistance; to his knowledge, no lives were lost.

Councilperson Hamon announced Sooner Success and the OU Health Sciences Center are partnering with various organizations to host an inclusive Hispanic Heritage Dance at Sellers Park on Saturday, September 16th, from 6 p.m. to 8 p.m. There will be games, snacks, traditional Mexican folk dancing, and lots of resources and opportunities to connect with various disability advocates and other community organizations. She is excited to attend, and she invites anyone who can to come out.

Councilperson Hamon mentioned she and Councilperson Nice attended the Local Progress National Convening last week, where they learned about equitable development and tenant rights legislation. She also went on site visits with various community organizations, including the St. Louis Office of Violence Prevention, to learn about efforts they are embarking on to respond to

gun violence, bullet-related injuries, self-harming, and public health. She noted that it was neat to see some of those innovative ideas that Oklahoma City is slowly moving towards, but they are more built out, and we can learn from those things that they are doing to plug in the gaps where some of our residents tend to fall into. She appreciated her opportunity to attend on a scholarship offered by Local Progress and the connections she made with other city councilors across the country who are working for equity in their communities.

Councilperson Nice echoed Councilperson Hamon's comments about the Local Progress National Convening. She said it was an amazing experience learning about opportunities and expanding ways to offer similar experiences to the residents within their respective wards as well as throughout the city.

Councilperson Nice thanked everyone, especially Ms. Debi, who helped her plan the town hall that was held yesterday at the Willa D. Johnson Recreation Center. She said it was a packed house, and she was grateful for the residents who attended, the city staff members, and the speakers who were invited to share information about the things that are going on within the community.

Councilperson Nice expressed that she is grateful for our friends at Kindred Spirits who acknowledged what happened Sunday evening. She clarified that security was present at the event, but the incident where someone lost their life did not necessarily occur on their property; it was brought there. She will continue to keep the family of that person in her thoughts. She added that bullet injuries and gun violence are epidemics, and we must do better and have more conversations about how to resolve the things that are happening within our communities and conflicts without the presence of weapons.

Councilperson Nice expressed her apologies to all her neighbors as she would not be able to participate in the "Neighbors Night Out" events tonight or Thursday. She has a class that she must attend. However, she will attend the one that is happening next week. She said she knows they will be great events, and she looks forward to continuing to support those neighbors throughout the rest of the year.


