Honorable Chairman and Trustees:

I. SCOPE

Amendment No. 2 adjusts plan quantities to match quantities in the field necessary for the completion of the project. Change Order No. 2 adds new pay items and additional Calendar Days to the contract.

II. JUSTIFICATION

Amendment No. 2 adds additional quantities for 16-inch pipe, fittings, and waterline removal to account for completing a reverse tap at the Vault B connection at Booster Pump Station No. 7. The reverse tap is necessary to avoid an existing ATT duct bank that is located adjacent to the 16-inch waterline that was not identified with the limited scope of survey and utility coordination.

Change Order No. 2 adds a pay item to the contract for installing two 16-inch caps on the existing waterline on the downstream side of the tapping sleeves at Booster Pump Station 7. This work will include the cost associated with placing required thrust protection.

Change Order No. 2 adds a pay item to the contract for Downey Contracting performing additional site exploration at Booster Pump Station No. 22 to identify potential unknown connections to the existing 16-inch waterline.

Change Order No. 2 adds pay items to the contract for one 16x1-inch tapping sleeve and a 20x1-inch tapping sleeve to be placed on the waterlines at Booster Pump Station No. 22 to verify which valve was inoperable and not shutting off water to the project location.

Change Order No. 2 adds a pay item to the contract for a 20-inch line to be installed at Booster Pump Station No. 22. There is an existing inline valve on the 20-inch line that is inoperable and is allowing water flow to the section of waterline to be demolished as part of this project.

Change Order No. 2 adds a pay item to the contract for the required flushing and dechlorination of the 20-inch waterline from Booster Pump Station No. 22 to MacArthur Boulevard.

Additionally, Change Order No. 2 adds a collective 32 Calendar Days to the contract. 23 Calendar Days are added to supplement the work required in constructing additional 16-inch waterline related to the reverse taps at Booster Pump Station No. 7. 9 Calendar Days are added to the contract for the delays associated with the procurement of the 20-inch Line Stop.

IV. COST SUMMARY

Amendment No. 2 is an increase of \$22,449.30 or 1.98 percent above the original contract amount. Amendment Nos. 1 through 2 represent an increase of \$132,317.30 or 11.67 percent above the original contract amount. Change Order No. 2 is an increase of \$60,117.51 or 5.30 percent above the original contract amount. Change Order Nos. 1 through 2 represent an increase of \$113,277.47 or 9.99 percent above the original contract amount. Amendment No. 2 and Change Order No. 2 result in an overall increase of \$82,566.81. The revised contract amount is \$1,379,333.37.

V. CONTRACT TIME

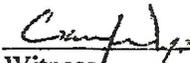
The original contract called for 90 calendar days. An additional 74 Calendar Days were added to the contract by Change Order No. 1. An additional 23 calendar days are added to the contract to install additional piping related to the reverse tap at Booster Pump Station No. 7. 9 Calendar Days are also added to the contract for the delays associated with the procurement of the 20-inch Line Stop. The total contract duration is now 196 calendar days.

The revised contract duration is 196 Calendar Days. The revised completion date is set as January 31, 2024.
