Commissioners,

I support Sisu Youth Services and their SPUD-1694 application. I reside at 2407 NW 31st Street in the Shepherd neighborhood, and my name is Peggy Big Eagle. Several of our neighbors work as staff, security or have interned at Sisu. Four other neighbors help me prepare the meals I serve each month. I hope to address some of the neighbors' concerns of which I am aware.

At the recent meeting at Church of the Open Arms it was incorrectly stated that clients come and go into the late hours of the night. Sisu has staff on site 24/7 with the following schedule:

9 a.m.-10 a.m. Closed

10 a.m.-1 p.m. Open for appointments

1 p.m.-7 p.m. Walk-in hours

8 p.m. Clients with overnight reservations must be checked in

9 p.m. Curfew (The only clients allowed in after that have a verified work schedule.)

The police officer at that meeting addressed the number of calls received from Sisu. He explained how a call reported from any address is no indication of where an incident occurred; it's likely where the caller was able to call from a safe place. I think it was reassuring to neighbors who had been told about a high number of calls from Sisu without knowing the context for those statistics. In our neighborhood, as in the whole United States, there is a common misconception of crime on the rise while in fact it's been mostly in decline.

There were similar comments about youth in nearby Swatek Park. Many of us, people of all ages and lots of families use the park, and presumably unhoused folks do also. The OKC Parks and Recreation Department has no reports of ongoing issues at Swatek, and police records show just nine calls to the park during the past two years.

When Sisu moved to the present location it became more visible in the neighborhood. They continue to work with so many organizations in addition to Shepherd Neighborhood Association for things like sidewalks, additional lighting for the park, and Embark for transportation which helps the whole neighborhood. Approval of this application will help Sisu provide better support services with administrative offices and more space for classes and resource connections .

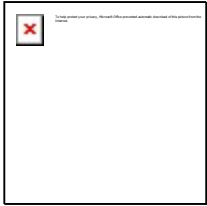

As you may have heard in recent national news stories, homelessness increased significantly all across the nation in 2024. Oklahoma City was not immune from that trend with our Point in Time count increasing 28% from 2023 to 2024 after more than a decade of essentially flat numbers. Our community has taken a thoughtful, collaborative approach to trying to bend that trend downward with Sisu being a significant component of that work. Because Sisu serves homeless and at-risk transition-age youth, their programs are particularly critical to our community's efforts as early intervention can help to prevent future homelessness. The programming space proposed in this SPUD will enable Sisu to provide the supportive services (healthcare, counseling, etc) that can end an individual's homelessness and intervene in the behaviors that could result in future homelessness.

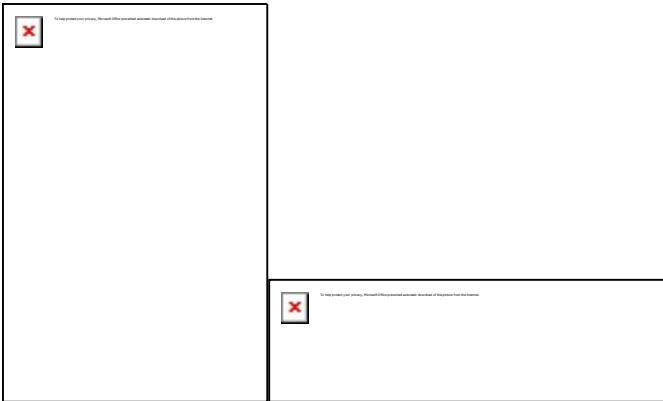

OCPD Chief Bacy confirmed on 12/31/24 that they have received a total of 42 calls to Sisu's address since Dec 2023 and only 9 calls to Swatek park over the past two years. The Parks and Rec Dept confirmed they have received no direct citizen's complaints about Swatek.



The chart below shows OCPD crime statistics for our area over the past 15 years.



As can be seen, the area surrounding 2129 NW 30th Street is indeed becoming safer and safer, including more dramatically since Sisu had its grand opening there a little over a year ago.
