Honorable Chairman and Trustees:

I. SCOPE

Amendment No. 1 adjusts plan quantities to match quantities in the field necessary for the completion of the project. Change Order No. 1 adds new pay items to the contract and contract time.

II. JUSTIFICATION

Changes in quantities reflect final measured amounts compared to initial design estimate. Amendment No. 1 is necessary to adjust for final quantities used during construction to complete the project. During construction, some extra point repairs were needed to continue pipe bursting operations. This led to an increase to the Pavement Cut and Permanent Repair (Concrete) pay item.

Change Order No. 1 adds pay items to ensure service lines were connect to residence in the area. The additional time request was due to conflicts created by private utilities that were bored through City's sanitary sewer which then blocked pipe bursting operations.

IV. COST SUMMARY

Original Contract Amount	\$2,336,771.50
Amendment No. 1	\$22,500.00 (0.96% increase)
Change Order No. 1	\$51,600.00 (2.21% increase)
Revised Contract Amount	\$ 2,410,871.50

Amendment No. 1 is an increase of \$22,500.00 or 0.96% above the original contract amount. Change Order No. 1 is an increase of \$51,600.00 or 2.21% above the original contract amount. Amendment No. 1 and Change Order No. 1 result in an overall increase of \$74,100.00. The revised contract amount is \$2,410,871.50.

V. CONTRACT TIME

The original contract called for 90 calendar days. An additional 180 calendar days are added to the contract to account for delays due to the Amendment and Change Order. The total contract duration is now 270 calendar days.
