

Notice to Bidders

Notice is hereby given that The City of Oklahoma City (“Awarding Public Agency”) will electronically receive and open sealed Bids for the construction of:

Project Number MB-1654

City Hall Sanitary Sewer and Storm Drain Line Replacement

in the Office of the City Clerk, 2nd Floor, Municipal Building, 200 N. Walker Avenue, Oklahoma City, Oklahoma 73102, until 10:00:00 a.m., on the 2nd day of October, 2024. Bids shall be opened electronically at the above stated time for receipt of Bids or as soon thereafter as practicable.

Bids must be made in accordance with this Notice to Bidders and the Bidding Documents, including all Addenda, which are available for examination through the electronic bidding system at <https://www.periscopeholdings.com/s2g> (formerly [www.bidsync](http://www.bidsync.com)).

To bid on this Contract, the Bidder must be prequalified by the City of Oklahoma City’s Prequalification Review Board on the Bid Date and Bid Time as: Class C Building Contractor.

Pre-Bid Conference: Mandatory Pre-Bid Conference will be held at 10:00 a.m. on September 5, 2024 at the Project site located at 200 N. Walker Ave, 2nd floor conference room. All potential bidders are responsible to read all Bidding Documents and submit questions in writing through the electronic bidding system by 4:00 p.m. on September 18, 2024. All additional questions in the meeting will be recorded in an addendum.

Bidder must complete the Project in accordance with the Bidding Documents, Addenda, and Oklahoma City Standard Specifications for Construction of Public Improvements by November 15, 2025.

The Maintenance Bond shall be in favor of Awarding Public Agency and shall be for a period of **2 years** in an amount equal to one hundred percent (100%) of the Contract amount.

Additional information is contained in the Bidding Documents. Prior to bidding this Project, Bidders must carefully examine the Bidding Documents, Addenda (if any) and the City of Oklahoma City Standard Specifications for Construction of Public Improvements. These Standard Specifications are incorporated by reference into the Bidding Documents except as expressly superseded by the Bidding Documents. Bidder is responsible for monitoring the electronic bidding website to determine whether addenda were issued and for opening and complying with all addenda.
