Joint Resolution with the Oklahoma City Municipal Facilities Authority approving use of \$68,967 from Oklahoma City Municipal Facilities Authority revolving funds to purchase easements in Oklahoma City's name for this General Obligation Bond Project; and upon the sale of all bonds designated for this listed project to authorize the expenditure of such 2017 General Obligation Streets Proposition Bond Funds by administrative transfer to The Oklahoma City Municipal Facilities Authority in the amount of \$68,967 for the purchase of said easements as necessary for the design, construction, and completion, of Project PC-0602, street widening improvements, South Harrah Road, I-40 to City Limits, within the arbitrage rule timelines; and authorizing the Oklahoma City Municipal Facilities Authority to administratively accept and deposit said bond funds into the Oklahoma City Municipal Facilities Authority revolving fund for future use on General Obligation Bond Projects as needed. Ward 4.

South Harrah Road, between I-40 and City limits.

**Background:**

This 2017 General Obligation Bond project provides for reconstruct, repair, and improvements of South Harrah Road between I-40 and the City limits

Final Plans are expected by Spring of 2023, with construction anticipated to begin Spring 2024.
