## **XII. Comments from Council**

Councilperson Cooper thanked Dr. Marilyn Dillon, Jason Ferbrache, Assistant City Manager and Director of Public Transportation and Parking and EMBARK staff member Becky for their help with connecting his mother to her physical therapy appointment yesterday in Midwest City, via EMBARK's Mobility Management Services. He said it meant a lot to him that we provide this service and encouraged anyone who needs access to the Daily Living Center, interim urgent need service, non-emergency medical appointments, shopping shuttle, EMBARK Well, which connects you to the wellness centers, or congregate meal shuttle to call (405) 297-2583 or Google EMARK Mobility Management for more information about the services we provide for individuals age 60 and over.

Councilperson Cooper mentioned the Academy Awards released their nominations last week. He noted the Oklahoma Film Critics Circle, founded in 2006 and on which he serves, released their list of best films and best actors and/or actresses. He said they received screeners from the movie studios beginning in October of the movies they wanted them to consider and invited them to advance screenings of films, one being *Killers of the Flower Moon*, which was directed by Martin Scorsese and shot here in Oklahoma with Leonardo DiCaprio. The "Critics Circle" awarded it as "Best Picture and

Lily Gladstone for “Best Actress.” There were other riveting performances in *The Zone of Interest* and *Anatomy of a Fall*. You can Google Oklahoma Film Critics Circle to view the full list.

Councilperson Hinkle thanked the Cascata Lakes and Lakeridge Run Homeowners Associations for inviting him to speak at their meetings last week. He said both were well attended by people who had great questions and were engaged. It was nice to see the turnout in Ward 5.

Councilperson Hamon thanked the Planning Department as well as all the other City staff members and service agencies who participated in the Point-in-Time count last Thursday, which is the annual count of people who are experiencing homelessness in Oklahoma City. She congratulated those who were involved with the implementation and/or deployment of a new digital application for the taking of surveys; they did a great job, and it appears the work is a lot easier for them on the back end of going through all the data.

Councilperson Hamon mentioned she attended the Oklahoma City Beautiful LitterBlitz at South Broadway Park this past Saturday. She stated that it was very cold and unpleasant, but there were over 20 volunteers who collected 25 or more bags of litter from around the park. She announced that on February 17, 2024, between 9:00 a.m. and noon, Oklahoma City Beautiful will partner with The City of Oklahoma City's Waterway Clean Sweep initiative to target certain wetlands and waterways within the city to ensure that debris and litter do not get caught up in those areas.

Councilperson Hamon announced the Homeless Alliance, along with some other organizations, will host the annual Homeless Memorial Service at the Day Shelter on Monday, February 12, 2024, at 3:00 p.m. She stated that they collected about 70 names of people who died while experiencing homelessness in 2023, and this is a time to hold space for and honor the lives of those people who did not have family or other communities to hold space or do the memorial for them. The memorial will be open to the public if you are interested in attending; it will be a nice space to reflect and think about how we can work better as a society to prevent that experience for people.

Councilperson Nice mentioned that they had a good turnout for the Martin Luther King, Jr. Holiday Parade on Saturday. She said it was cold but honoring the legacy of Dr. King is always important for us to do throughout our country, and in her opinion, it is very special because of his relationship and familiarity with Oklahoma City; not many cities can say that. She thanked all the City staff that attended and the different City departments that were represented in the parade. The City of Oklahoma City placed in one of the categories, so congratulations on the award. She noted the essay and poster contest is still happening for the Tree of Life celebration in April at the Oklahoma State Capitol. Councilperson Nice thanked the City staff, assistant city managers, directors, and assistant directors who attended the Ward 7 Town Hall last Tuesday. She said they had good attendance with well over 150 people, which tells us that people want to know what is happening within our community and around Ward 7. She also thanked Ms. Debi for her assistance and Mount Olive Baptist Church for hosting it in their A. G. Woodberry Family Life Center.

Councilperson Nice announced Thursday, February 1, 2024, kicks off Black History Month and each year the Association for the Study of African American Life and History, founded in 1915 by Carter G. Woodson, comes up with a Black History theme and this year it is “African Americans and the Arts.” She said she hopes that as a city we will take a careful view of how African Americans have impacted the arts in Oklahoma City and that we can celebrate and honor the culture and legacy of the things that

have happened within Deep Deuce, which is a part of the arts, and the many murals that we have seen placed around our community by artists of African American hues.

Councilperson Nice discussed the importance of understanding the historical aspect of Diggs Park, as it was where, during Clara Luper's era, they would go each year for the Freedom Fiesta to celebrate. She stated that having the ability to reel in on how to protect this park and the legacy and accomplishments of our community with the Freedom Fiesta is part of why we must continue to look at these decisions and how they would impact the areas within our community and walls.

Councilperson Nice mentioned it is important to note those who said no to the resolution that was presented regarding the county jail. She said many people have asked what the Mayor's comments were on it and she did not know, but it was very evident today with the no vote. She hopes we can ask for accountability from those who we have not heard from in these specific conversations.

Councilperson Stonecipher announced the passing of a great community leader, Bob Ravitz, last week. He shared some thoughts he wrote about him and encouraged those who did not know Mr. Ravitz to read his obituary from Smith & Kernke Funeral Home. It is a great read. He said he had the greatest smile in the world and will be missed, but not forgotten.

Councilperson Stonecipher thanked The Boeing Company, particularly Todd Pauley, Director, Government Operations for taking him and Councilperson Carter on a tour yesterday. It was amazing to see the state-of-the-art job we do in the areas of engineering and maintenance here in Oklahoma City. The tour was great, and he got to see an old friend, Sandy Coates, who is a Senior Counsel there. He also mentioned that Boeing has 3800 employees and is currently hiring.


