Joint Resolution with The City of Oklahoma City Authority authorizing the Director of Risk Management and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2022-03333P styled: *Kelli Woolley, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

Background:

The Claimant, Kelli Woolley is 61 years old and a 26-year employee of The City of Oklahoma City. At the time of the injury she was assigned to the Information Technology Department as a System Support Specialist II and continues to be employed by the City.

Claimant sustained an undisputed accidental injury on October 1, 2020 to her neck and left shoulder. The Claimant required surgery to her left shoulder on September 15, 2023.

The negotiated Joint Petition Settlement calls for a PPD award of \$41,720 for the following permanent partial disability: neck 12%, left shoulder 15%, upper left arm 8%. The settlement includes a payment of \$780, for additional consideration for a total award of \$42,500.

The settlement further calls for a 3% assessment of the PPD award, less the payment of the additional payment amount, in the sum of \$1,251.60 be deducted and paid on behalf of the claimant for the Multiple Injury Trust Fund Tax, making the lump sum award, including the additional payment, \$41,248.40. The settlement further calls for \$8,500 to be deducted from the PPD award and paid in a lump sum to the Claimant's attorney as a fair and reasonable fee. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, including the additional payment, shall be paid in the sum of \$318.75 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, less the additional payment, shall be paid in the sum of \$834.40.
