

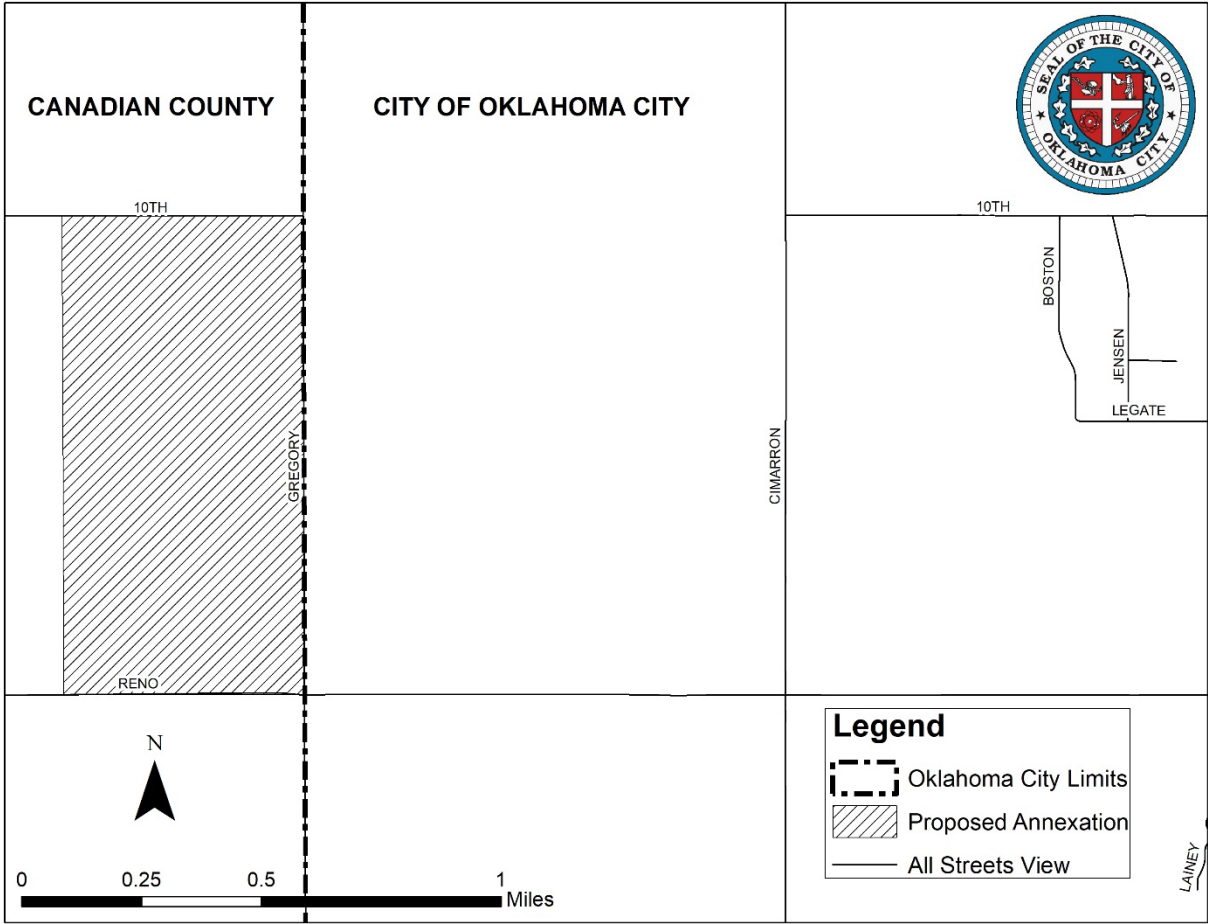


Map of Proposed Annexation
