**ORDER NO. 24-XX**

**ORDERING AN EXTENSION THROUGH DECEMBER 31, 2025,  
OF THE PENALTY REDUCTION PERIOD THAT ORIGINALLY  
BEGAN JULY 1, 2019 FOR DEFENDANTS WITH WARRANTS  
FOR CLASS “A” OFFENSES THAT OCCURRED ON OR BEFORE  
DECEMBER 31, 2022.**

Originally beginning July 1, 2019, through March 31, 2020, and subsequently extended several times continuously through December 31, 2024, a penalty reduction period was ordered during which a defendant with a warrant for a class “a” offense that occurred prior to July 1, 2017 (extended to include warrants for class “a” offenses that occurred on or before June 30, 2021) shall be permitted to close any such case with a single payment at a reduced cost without the necessity of appearing before a judge. Payments will be assessed as shown in the attached table. Any companion Failure to Appear shall be dismissed without costs.

In a situation in which the defendant indicates they are unable to take advantage of the program due to financial hardship, the cases shall be scheduled for indigency hearings with appropriate information provided to the defendant.

The penalty reduction period is now extended through December 31, 2025 and will include defendants with warrants for class “a” offenses that occurred on or before December 31, 2022.

This order is effective January 1, 2025, amending Orders 19-05, 20-05, 20-09, 21-03, 22-02, 22-06, 22-07, 23-02, 23-05 and is intended to provide for a seamless extension of the program.
