

**OBJECTION TO ZONING CHANGE IN CONNECTION WITH CASE
NUMBER SPUD-1597 (PROVIDENCE CREEK, LLC)
(UPDATE TO OUR PREVIOUS OBJECTION)**

Subject to our previous objection, we have learned additional information, which we believe is very pertinent to the applicant's request.

During the latter stages of the development of the Fountains at Hidden Creek, as described in our previous objection document, we learned the fire department had concerns regarding the addition of more houses in the northern parts of this development. These houses are adjacent to Providence Creek. Ultimately, these houses were mandated to have fire suppression systems, reportedly.

Additional facts regarding this matter are as follows:

- At this point there are approximately 330 homes which are required to go through the entrance to Hidden Creek at the intersection of 122nd and Hidden Creek Boulevard
- This is the only entrance and exit which exists for these 330 homes.
- Approximately, 185 of these existing homes must pass over the 75 ft bridge, which spans an existing creek.

In summary, it is the strong opinion of the many residents of the Hidden Creek developments that adding 16 more houses in Providence Creek presents unreasonable density issues and represents a potential safety concern for emergency vehicles accessing this area. This opinion is based on the above information as well as the previously submitted information.
