## XII. Comments from Council

Councilmember Carter reminded everyone not to call 911 to report illegal fireworks. Please call the Fireworks Hotline at (405) 297-2222. He wished everyone a good and safe week.

Councilmember Stone wished everyone Happy Fourth of July, and he reminded everyone to stay safe.

Councilmember Hinkle congratulated the Oklahoma Charge Volleyball Team for winning the 14UA AAU National Championship in Orlando, Florida, a couple of weeks ago. He said Bella Holasek was recognized as the "Most Valuable Player" in the tournament and that Oklahoma City is doing well across the country.

Councilmember Nice mentioned that Councilmember Cooper served as Grand Marshal of the Pride Parade. She said it is always fun to celebrate the things we do, and she expressed her gratitude to Councilmember Cooper for leading the parade. It showed how we, as a city, can, but do not accept, the things around us as well as the people who live within our city limits. It was a joyful experience.

Councilmember Nice encouraged everyone to ride the EMBARK bus on the 3rd Friday of each month free of charge for our city to connect with the folks you live around and understand where, if any, the gaps are in transportation.

Councilmember Nice mentioned that last weekend, she had the opportunity to join the Kappa Alpha Psi Fraternity Incorporated for their Cabana River Cruise event with our EMBARK Department. She said it was nice to experience our city and see the Okana development, learn more about the things that are happening, such as the upcoming pedestrian bridge, cruise the Boathouse District, and understand all the positive things that will come to that part of our community.

Councilmember Nice stated that she met with our Parks Department and members of the Minnis Lakeview Park Steering Committee last night. She praised Naisha Morris of the Parks Department for her tremendous efforts in helping to accommodate and revive the recreation center within Oklahoma City's Spencer community, as well as ensuring that the programming is crafted in the way the community has asked. She expressed her gratitude to Naisha for working hand-in-hand with our neighbors and residents who live in this part of our community. The center's grand reopening is scheduled for August 24, 2024.

Councilmember Nice thanked Michael Clark, another city staff member from Engineering, and August Mothershed, a resident, for meeting with her to continue discussions about the bike lanes on North Lottie Avenue and their impact on the neighborhood and community.

Councilmember Nice announced the Regional Conference for Delta Sigma Theta Sorority, Inc., will be held next week. She said there will be lots of ladies downtown wearing red, so if you see them, please say hello and show them the beautiful spirit of Oklahoma City.

Councilmember Nice stated that LiveFree OKC held a press conference yesterday on gun violence and other issues affecting our communities and neighborhoods. They also discussed how we can navigate those issues and work together to prevent gun violence and accommodate our residents. She mentioned that the Surgeon General recently declared shootings and gun violence a public health crisis in our nation. Oklahoma City is not excluded from those numbers that we see in inner-community or overall violence because of laws not requiring background checks or other preventive measures for states. She hopes that we will continue to look at how these things impact our communities, especially as we look at the recommendations that we continually work on and talk through for our city.

Councilmember Nice expressed that she hopes everyone has a good week.

Councilmember Stonecipher pointed out that Item PPA.E. on the agenda today was a resolution accepting a \$20,000 donation from the family of Leon Elliot. He stated that Mr. Elliot's family wanted to make a donation in his name to Lincoln Park Golf Course as it meant a lot to him, and he spent a lot of time playing golf there. The family also requested that the donation be used for its continued upkeep and beautification. Councilmember Stonecipher commented that he is always proud when people make contributions like this, especially when it is for Oklahoma City's beautification.

Councilmember Stonecipher mentioned that Oklahoma City opened the Bricktown Canal 25 years ago today. He noted that Debi Martin oversaw the opening, which attracted an estimated 25,000 people. He believes that this project is the catalyst for what makes Oklahoma City great. It has had an incredible economic impact, generating \$629 million, supporting 5,331 jobs, and contributing to an additional 2,347 jobs in the area. The project is going well, and he is very proud.

Councilmember Peck asked residents to keep our military service members in their thoughts and prayers during the Fourth of July holiday, as many of them are not home celebrating with their families; they are continuing the "good fight" to ensure that we enjoy the freedoms that we have today.

Councilmember Peck commented that she had the opportunity to attend the Regional Transportation Authority Board meeting last week, where routes and methods for additional corridors were approved. She noted that presentations on the north and south bus rapid transit lines were provided today; the Western Avenue and Airport corridors are coming soon and will serve both our Oklahoma City residents and guests. She enjoyed interacting with Chairman Henry and the board, as well as the work that Kimley Horn is putting into the upcoming projects. She is excited about what is to come.

Councilmember Peck requested that we continue to keep our police and fire service members in our thoughts and prayers, as they had a difficult task to complete last evening, rescuing a member of the police and fire family from a situation that resulted in a loss of life. We lift our police officers, firefighters, and all those involved in that rescue attempt, as well as Karen Fox and city staff who may have known her son.




