Utility Electric Facilities Relocation Agreement with Oklahoma Gas and Electric Company, Project DC-0298, Drainage Improvements, Twisted Oak Road and Oak Hollow Road to Quail Creek Golf Course, not to exceed \$650,000. Ward 8.

Location:

Twisted Oak Road and Oak Hollow Road to Quail Creek Golf Course

Background:

This 2017 General Obligation Bond project provides for drainage improvements in the vicinity of Twisted Oak Road and Oak Hollow Road to Quail Creek Golf Course to reduce flooding and eliminate further erosion from the creek bank.

Located within the construction limits of this project is an electric distribution line, which must be relocated in order to construct this project. The City will pay for this relocation due to it being on a private easement.

This agreement allows for the reimbursement of cost related to the relocation of the distribution line to facilitate the drainage improvements.

Relocation is expected to begin Fall 2024 and be completed Winter 2024.
