Joint Resolution with The City of Oklahoma City authorizing the Director of Risk Management and the Trust's legal counsel to enter into a Joint Petition Settlement of the Workers' Compensation Commission Claim No. CM3-2023-04292Y styled: *Nyree Campbell, Claimant vs. The City of Oklahoma City, Respondent*, an Own Risk Carrier, and further authorizing the Municipal Counselor to assist said counsel in the rendition of said Joint Petition Settlement to Judgment as authorized by 85 O.S. §346, 62 O.S. §§365.1 *et seq.* and Article 10, Section 28 of the Oklahoma Constitution.

### Background:

The Claimant, Nyree Campbell is 44 years old and a 4 year employee of The City of Oklahoma City. At the time of the injury she was assigned to the Utilities Department as a Field Customer Service Representative and continues to be employed by the City.

The Claimant sustained an undisputed accidental injury on July 18, 2023 to her right knee and right shoulder. The Claimant required surgery to the right shoulder on January 25, 2024.

The Claimant was evaluated by Dr. Lonnie Litchfield on behalf of her attorney and found to have the following permanent partial impairment: right knee 33%, right shoulder 7%. The Claimant was also evaluated by Dr. William D. Jones on behalf of the City and found to have the following permanent partial impairment: right knee 0%, right shoulder 6%. The negotiated Joint Petition Settlement calls for a PPD award of \$23,778 for the following permanent partial disability: right knee 7%, right shoulder 13%.

The settlement further calls for a 3% assessment of the PPD award in the sum of \$713.34 be deducted and paid on behalf of the Claimant for the Multiple Injury Trust Fund Tax, making the lump sum award \$23,064.66. The settlement further calls for \$4,755.60 to be deducted from the PPD award and paid in a lump sum to the Claimant's attorney as a fair and reasonable fee. In addition, the City will pay Court costs \$140, a Special Occupational and Safety Fund tax representing .75% of the permanent partial disability award, shall be paid in the sum of \$178.34 and the Workers' Compensation Administration Fund, representing 2% of the permanent partial disability award, shall be paid in the sum of \$475.56.
