RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE THE CERTIFIED LOCAL GOVERNMENT'S NATIONAL REGISTER NOMINATION REPORT FOR THE PERRINE BUILDING, 119 NORTH ROBINSON AVENUE, OKLAHOMA CITY, OKLAHOMA, WHICH INCLUDES AN AFFIRMATIVE STATEMENT OF OPINION REGARDING THE BUILDING'S NATIONAL REGISTER OF HISTORIC PLACES ELIGIBILITY FOR THE REASONS STATED HEREIN, AND THEREFORE RECOMMENDING THE PERRINE BUILDING TO THE OKLAHOMA STATE HISTORIC PRESERVATION REVIEW BOARD AND THE KEEPER OF THE NATIONAL REGISTER OF HISTORIC PLACES, WASHINGTON DC, AS ELIGIBLE FOR THE NATIONAL REGISTER. WARD 6.

WHEREAS, The City of Oklahoma City has participated in the Certified Local Government's (CLG) Program with the Oklahoma Historical Society, State Historic Preservation Office since January 1991; and

WHEREAS, The National Register of Historic Places includes "districts, sites, buildings, structures, and objects that exhibit a quality of significance in American history, architecture, archaeology, or culture that possess integrity of location, design, setting, materials, workmanship, feeling and association;" and

WHEREAS, The Historic Preservation Commission at their regularly scheduled meeting on March 5, 2025 concurred with the National Register nomination, as prepared, that the Perrine Building is eligible for the National Register under Criteria "A" and "C;" and

WHEREAS, National Register Criterion "A" provides recognition for properties "that are associated with events that have made a significant contribution to the broad patterns of our history;" and

WHEREAS, National Register Criterion "C" provides recognition for properties "that embody the distinctive characteristics of a type, period, or method of construction or represents the work of a master, or possesses high artistic values, or represents a significant and distinguishable entity whose components lack individual distinction;" and

WHEREAS, The City of Oklahoma City, as a part of being a Certified Local Government, has completed a *Certified Local Government National Register Nomination Report* for the Perrine Building which includes a statement of opinion from the local review commission and the chief elected official;

NOW, THEREFORE, BE IT RESOLVED THAT:

1. The Mayor is hereby authorized to execute the *Certified Local Government National Register Nomination Report* for the **Perrine Building** including an affirmative statement of opinion regarding the property's National Register of Historic Places eligibility for the reasons stated herein.

2. **Perrine Building** is hereby recommended to the Oklahoma State Historic Preservation Review Board and the Keeper of the National Register of Historic Places, Washington DC, as eligible for the National Register.
