

**FIRST RENEWAL OF AMENDED LEASE AGREEMENT**

This First Renewal of Amended Lease Agreement ("1<sup>st</sup> Renewal") is entered into as set forth below between the Oklahoma City Public Property Authority ("OCPPA"), The City of Oklahoma City ("City"), and Healthy Living & Fitness, Inc. ("Operator").

RECITALS:

**WHEREAS**, the City provides a variety of parks and recreation venues and services for the use and enjoyment of the public; and

**WHEREAS**, OCPPA is a public trust of which the City is sole beneficiary; and

**WHEREAS**, the City's MAPS 3 program included construction of new health, wellness, and aquatic centers designed for seniors, to be operated and maintained by one or more partners contracted with the City and/or OCPPA; and

**WHEREAS**, the MAPS 3 Senior Health and Wellness Centers promote healthy lifestyles, enhance well-being, and support social engagement of adults aged 50 and over; and

**WHEREAS**, on February 9, 2016, OCPPA, the City, and Operator entered into a Lease and Management Agreement ("Agreement") for MAPS 3 Senior Health and Wellness Center No. 1, located at 11501 North Rockwell Avenue; and

**WHEREAS**, on July 18, 2017, that Agreement was amended to modify provisions related to facility rentals and the Operator's insurance requirements; and

**WHEREAS**, the Agreement, as amended, includes an initial term of five (5) years, with the option, upon mutual consent, of three (3) additional, five-year (5-yr.) terms; and

**WHEREAS**, the initial term expired on February 8, 2021; however, due to an administrative oversight, it was not formally renewed; and

**WHEREAS**, to date, Operator has complied with the Agreement terms, as amended, and continued providing the public benefits contemplated therein; and

**WHEREAS**, the City and OCPPA wish to retroactively enter into this 1<sup>st</sup> Renewal to allow for the successful management, operation, and administration of MAPS Senior Health and Wellness Center No. 1.

**NOW, THEREFORE**, the parties agree:

1. **FIRST RENEWAL TERM**

- A. OCPPA, the City, and Operator hereby enter into this 1<sup>st</sup> Renewal to allow Operator to continue its management and operation of MAPS Senior Health and Wellness Center No. 1, as provided for in the amended Agreement.


