 Water Meter Vault Replacement Program, Year 1
 Citywide

Honorable Chairman and Trustees:

I. SCOPE

Amendment No. 5 is the final amendment to reconcile all the quantities installed in the field. Change Order No. 5 adds new pay items and a time extension to the contract.

II. JUSTIFICATION

Amendment No. 5 reconciles all the differences between the estimated and actual quantities installed during the construction of this project. The construction of the meter vault at the VA Hospital site has been taken out of the scope of this project. It is due to utility conflicts, and the required easement from the VA Hospital could not be obtained. All the bid items associated with this site will be deducted from the total cost of the project.

Change Order No. 5 adds the stored materials purchased for the VA hospital site, which consist of the components within the bid item pre-cast meter vault and 8" PVC water pipes. This change order also adds 120 calendar days to complete the project.

Amendment No. 5 is a decrease of \$113,481.50 or 6.74 percent below the original contract amount. Amendment Nos. 1, 2, 3, 4, and 5 represent a decrease of \$152,003.50 or 9.03 percent below the original contract amount.

Change Order No. 5 is an increase of \$7,181.63 or 0.43 percent above the original contract amount. Change Orders 1,2,3,4, and 5 represent an increase of \$67,761.63 or 4.03 percent above the original contract price. The revised contract amount is \$1,598,520.13.

V. CONTRACT TIME

The original contract called for 230 calendar days with a start date of July 21, 2020. Due to the delays for the remaining locations impacted by the unforeseen utility conflicts, One Hundred Twenty (120) calendar days are added to the Contract under this Change Order making the current contract time One Thousand One Hundred Forty-Nine (1,149) calendar days.

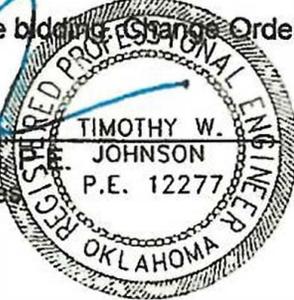
