

RESOLUTION OF THE OKLAHOMA CITY WATER UTILITIES TRUST EXTENDING TIME TO AWARD CONTRACT AS MUTUALLY AGREED, AWARDING CONTRACT TO BREWER CONSTRUCTION OKLAHOMA, LLC, PROJECT WM-0426, HEFNER DAM WALL REPAIR, LAKE HEFNER PARKWAY AND EAST WHARF DRIVE; WEST LAKE HEFNER DRIVE AND WEST BRITTON ROAD, \$172,947; AND APPROVING THE CONTRACT AND BONDS.

WHEREAS, Project WM-0426 provides for the construction of barriers that will prevent vehicles from exiting the roadway at the two intersection locations; and

WHEREAS, the Oklahoma City Water Utilities Trust (OCWUT) has advertised and received bids for Project WM-0426; and

WHEREAS, the Public Competitive Bidding Act of 1974 states that a contract for construction of a public improvement must be awarded within 30 days or within 45 days for good cause shown or within 120 days upon mutual agreement between the lowest responsible bidder and the awarding public agency or agencies; and

WHEREAS, it is the desire of OCWUT to award the contract to the lowest and best responsible bidder; and

WHEREAS, the bids were opened on May 29, 2024; and

WHEREAS, this contract was delayed due to necessary review period requirements and the meeting schedule of the Oklahoma City Water Utilities Trust; therefore, preventing award within 30 days of receipt of bids; and

WHEREAS, a letter agreeing to honor the bid for 48 days has been received from Brewer Construction Oklahoma, LLC.

NOW, THEREFORE, BE IT RESOLVED by the Trustees of the Oklahoma City Water Utilities Trust that they do hereby extend time to award contract as mutually agreed, award contract to Brewer Construction Oklahoma, LLC, Project WM-0426, Hefner Dam Wall Repair, Lake Hefner Parkway and East Wharf Drive; West Lake Hefner Drive and West Britton Road, \$172,947; and approve the Contract and Bonds.
